may be lower than 10% for individuals based on their usage.

The minimum bill for water will now cover the first 2,000 gallons of water usage, with the price of that bill varying based on the diameter of the pipes at the water meters. Each 1,000 gallons of water used after that will be an additional \$12. Base prices for water are not finalized.

The minimum sewer rate will be a flat \$32, covering the first 2,000 gallons. Each additional thousand gallons of usage will be a charge of \$13.50.

"Our fixed income and our low income people are protected more, so they see less of an increase because it's a flat rate for 2,000 gallons." Jackson said about the city's plans to adjust the base galprevious plan.
