Starks, Facilities Division, Administrative Office of the Courts, 1001 Vandalay Drive, Frankfort, KY 40601-9320. (FAX responses will not be accepted.) Each proposal should include the type, location, and availability date of the property. Also furnish an exterior photo, and floor plan showing the interior layout of the existing building to include walls, doors, windows, and columns. All proposals must be received before 1:00 PM EST, Wednesday May 22, 2024. All bids received will be opened and publicly read at the AOC offices at that time in Conference Room A. A representative of the AOC will make an appointment to inspect all proposed lease space that meets the requirements stated above. A determination will not be made until a visual inspection of all proposed properties has been made. Property must be approved by the Department of Housing, Buildings, and Construction, Division of Building Codes Enforcement, and must meet OSHA and the Americans with Disabilities Act specifications, as well as existing applicable building codes.
