## Bridge project moving forward

Gov. Andy Beshear joined Ohio Gov. Mike DeWine on Friday to announce that the two states have received federal environmental approval to move the \$3.6 billion Brent Spence Bridge Corridor project forward, without tolls.

The Federal Highway Administration (FHWA) has issued a decision that ends the federal environmental review, allowing the project to advance to design and construction.

"The Brent Spence Bridge Corridor project is a testament to what can happen when we work together to get things done," said Gov. Beshear. "The federal approval is a major milestone for us, and we're grateful to all our partners and communities for their feedback. We look forward to completing this project, which will further boost our economic growth and create more good jobs for our families.

"This is an important step forward in bringing efficiency to our nation's supply chain," stated Gov. DeWine. "The project will address one of the worst truck bottlenecks in the nation by improving safety and travel on an interstate connection that carries more than \$400 billion worth of freight every year. It's also a big step in reducing the frustration and inconvenience drivers have experienced in the corridor for more than 20 years."

Christopher reiterated several times he "can only appoint" and that it is "up to council to approve [or disapprove] my appointment."

Members of the council appeared to misunderstand his intentions, confusing "interim" with "permanent" and "appointment" with "approval.

Councilmember Kim Crupper indicated the way he read the mayor's May 1 email, "Basically you can hire him, pretty much without our blessing."

Christopher answered "That is not correct" and clarified that, according to the city ordinances, he can appoint someone as chief and that person "is interim chief until council either approves of my appointment or denies my appointment."

Christopher said he appointed Willoby as chief, however he would not become permanent fire chief until approved by council. He related this was the process used to fill the Williamstown Chief of Police position recently.

Councilmember Gina Austin Smith asked for clarification. "What are we voting on ... here-" interim or permanent position?

Coleman asked "Interim for two days, and now we are hiring?'

Crupper asked, "Should we have publicly advertised for a Williamstown fire chief?"

Austin noted, "We don't have to; we just do what we want...?'

Crupper continued, "We should, as an equal tised if we are going to have a fire chief.

Coleman asked what type of commitment Willoby could give the council, with his having been appointed to counbefore and then resigning and taking on the fire chief's position; what assurance could he give he would not "decide retirement was better" than being fire chief.

Willoby said he felt he could be more effective to the community as fire chief; on the council he was just "one

Alex Cummins accompanied City Clerk Vivian Link in discussions of the upcoming budget.

Link asked that council go through the proposed budget page by page.

As she noted the Philippo said he amount of attorney fees had increased "quite a bit" Crupper spoke up. "You're still light on

that." He indicated the attorney's fees would possibly have to be doubled "but that's just my opinion."

Christopher noted budget items such as "grant writer" and a "code enforcement officer" were more of a "wish list" than a requirement.

Crupper said, "There are going to be several capital expenses and things that you are going to have to slice out to balance your budget because you gotta keep in mind, this year for 2024-25 you've positioned yourself to where you simply cannot borrow no money right now, so anything you want to buy that is a sizable item you want to have to finance, you got to forget it."

Crupper later noted the city cannot borrow money due to "the lawsuit." Over the course of the evening, Crupper proceeded to "slice out items" to "get the general fund back up.'

Items on the chopping block included vehicles, Conrad Lane repairs, street department vehicle and equipment, police cruisers and sidewalks.

## **UPGRADING CITY BILLING SYSTEM**

A required upgrade to the billing system cannot be removed from the budget as the system must be upgraded in 2025. The current system becomes obso-

lete at the end of 2024. Alex Cummins, of the clerk's office, said the new system can have autopay with electronic draft so can have immediate payments without lag time for payments. The system will have email notification options but will also continue paper mailing and in-person payments.

Council preliminarily decided to include the credit card fee to be passed on to customers. It is currently costing the city approximately \$48,000 per year.

The fee the customer will see is: \$2.50 on charges up to \$50; over that will be a 2.5%

Cummins said if approved prior to July 1, the city will receive a \$9,000 credit. Final decision on this matter will be done later in the budget discussions.

In a vote of four to one with Coleman voting "no," council moved into closed session to discuss the replacement of city council member Willoby.

Upon exiting the closed session, council moved to vote to name replacement for Willoby. Coleman exited the meeting, "stepping down" so as not to cast a vote.
