New Castle reads \$2.4M budget, garbage collection rate

During their May meeting, the New Castle City Commission held their first reading of the city's proposed budget of \$2.4 million for the upcoming fiscl year beginning July 1.

The budget features about \$1.3 million in beginning balance carryover from the current fiscal year across these four categories:

- General Fund \$478,921
- Water Fund \$463,225
- Sewer Fund \$335,922 Fire Department \$12,250

The projected revenues for the fiscal year include nearly a half-million dollars in collection through the General Fund and more than a half-million dollars in combined water and sewer revenues.

Total expenses projected are as follows:

- General \$714,394
- Water \$355,548
- Sewer \$305,083
- Fire Department \$71,547 The public hearing and sec-

ond reading for the budget will be set prior to the budget adoption by July 1.

The commission also held the first reading for the garbage collection franchise

award by the city to Rumpke Waste & Recycling at a cost of \$27.49 monthly for residential garbage collection for the next two years with an option for the city to accept third and fourth year rates of \$28.59 and \$29.73 monthly.

"We lowered the franchise fee to lower the garbage costs for the citizens of New Castle," said Mayor Phoebe Thompson.

While the lowered franchise fee collected by the city from Rumpke lowers the overall cost of garbage collection for city residents, the award to Rumpke amounts to a \$2 increase in monthly service from the current rate.

Rear-door garbage collection is set for \$36.49 monthly.

After a public hearing and second reading of proposed ordinance held by the commission during the May meeting, the commissioners established the city position of public works assistant director and promoted current public works employee Vincent Bates to the position.

Also during the commission meeting, commissioners Jennifer Delling and Charlie Sevier addressed the upcoming city-

Council discussed the possibility of a 5% tax for packaged alcohol retailers, who have currently do not pay tax to the city for alcohol sales, while keeping the current 2.5% tax for alcohol sales at restaurants the same.
