AMENDMENT TO OCCUPATIONAL TAX ABATEMENT
ORDINANCE NO. 430.1

THIS AMENDMENT TO ORDINANCE 430.1: AMENDMENT: SECTION 3 (1)-Occupational License Tax Payment Required

(1) Except as provided in this Section, every person or business entity engaged in any business for profit and any person or business entity that is required to make a filing with the Internal Revenue Service or the Kentucky Revenue Cabinet shall be required to file and pay to the County an occupational license tax for the privilege of engaging in such activities within the county. The occupational license tax shall be 1.5% of all wages and compensation paid or payable in the county for the work done or services performed or rendered in the county by every resident and nonresident who is an employee.

This amendment effective date shall be October 1, 2023.
