Community honors law enforcement officers who made the ultimate sacrifice

Members of the Paducah Police Department, the McCracken County Sheriff's Office, the McCracken County Jail, and the public gathered on the lawn of the McCracken County Courthouse Monday to honor law enforcement officers who were killed in the line of duty in 2023.

The Jackson Purchase Fraternal Order of Police organized the event. The organization is dedicated to improving the working conditions of law enforcement officers.

Paducah Police Chief Brian Laird said Monday marked the first time the event was held locally since the COVID-19 pandemic.

"This memorial service is a staple that we've done in this community for many, many years put on by the local Fraternal Order of Police, and we're just glad to be able to get out and recognize the officers that have made that ultimate sacrifice," Laird said.

The ceremony started with the presentation of colors and with McCracken County Commissioner Richard

Abraham singing the national anthem.

McCracken County Attorney Cade Foster spoke about dealing closely with deputies and officers who work hard to protect the people of the commonwealth.

In 2023, 137 law enforcement officers in the U.S. in the line of duty. That number was written on a blue and white wreath that was placed in front of the fallen officers memorial on the lawn of the court-

house. Members of the Honor Guard played "Taps" on the trumpet, as the flag was lowered to half-staff.

Kentucky Supreme Court Justice Shea Nickell attended the ceremony and sang Kentucky's state song, "My Old Kentucky Home."

Nickell has been attending these ceremonies since he was an assistant McCracken County attorney.

On May 1, 2024, Caldwell County Sheriff's Deputy Stacey Blackburn arrested Katie Stokes 39, of Cadiz KY on a warrant out of Trigg County Circuit Court. Ms. Stokes was lodged in Caldwell County Jail.

On May 5, 2024, Caldwell County Sheriff's Deputy Ashley Copeland was dispatched to Stephens Lane and Hwy 62 East in response to a single-vehicle accident. Upon arrival, the driver had already left the scene. Deputy Copeland was notified the driver and a passenger had arrived at home. Deputy Stacey Blackburn made contact with the driver and passenger, as well as requested EMS for the driver to be transported to the Caldwell County Medical Center. After further investigation, Deputy Copeland charged and arrested Jennifer Messamore, 45, of Princeton, Kentucky with wanton endangerment, 1st degree; assault, 4th degree; dating violence (minor injury); operating motor vehicle under influence of alcohol, 1st degree; operating motor vehicle under influence of substance 1st (aggravated circumstance) and no operators/moped license.

Kevin Dzikowski, 40, of Princeton, Kentucky, who was a passenger in the accident, was also charged and arrested by Deputy Blackburn for violation of conditions of release. Both Ms. Messamore and Mr. Dzikowski were lodged in the Caldwell County Jail. Deputy Ashley Copeland was assisted by Deputy Stacey Blackburn and the Caldwell Co EMS.


