Shelter has been offered to Anderson County residents at the Woodford County Red Cross shelter at 185 Beasley Drive. Womack added they have a representative from the National Guard coming for assistance. They have also been working tightly with the county fire department and all of their department has been Kentucky State Police.

"We are a very strong community, everyone here has been very giving and very offering. We will try to utilize those people as the needs unfold," Womack stated.

Womack stated the course of action as of now includes dispersing the water and making contact with people that left the Tyrone and the Gilbert's Creek area to make sure their needs have been met. She added anyone in the county that has been impacted but not reached out to the EOC to do so immediately.

Anderson County Schools were also affected by the flooding and were closed Monday, April 7, 2025. In consultation with Anderson County Emergency Management as well as county and city government officials, the decision was made on Sunday, April 6 been made to cancel classes due to potentially dangerous conditions and as a community water conservation measure.




