## **THE WAY WE WERE**

#### 60 years ago June 24, 1965

three indictments were returned by the Anderson County grand jury Monday on the opening day of the June term of the court. Judge Henry Meigs II of Frankfort presided Monday in the absence of Judge Coleman of Shelbyville, who was unable to be present because of the death of his brother-in-law who was killed in alabama. William Mills and Charles Peffer, both of frankfurt, were indicted on a storehouse breaking charge. The men had been held by the lower court to the alleged charge of breaking into the Sinclair Oil station, owned by Robert Cammack on North Main Street on May 6th, 1965. Monday afternoon the men appeared before judge Meigs and through their attorney Ralph Horman, entered pleas of guilty and were given one vear each in the state Reformatory. Both of the men had just been released from the Reformatory a short time before the break and occurred in Anderson county. The state will give reassessment guidelines to local tax Commissioners in the next few weeks Revenue Commissioner lames Luckett said this week. He said his agency is studying various ways of abiding by the court of appeals decision ordering the fair cash value on all properties starting January 1, 1966. Luckett said his department is inventorying All Counties to determine particular problems in each and to formulate procedures whereby the tax commissioner can proceed. He added there is a disparity among the counties in up-to-date appraisals, equal assessments and useful records. Luckett

said in an appellate court decision last Friday there was an important clue. He said the court spelled out that full value means a close approximation. he added it is what reasonable people would agree is full value.

Property in Kentucky must be addressed at its Fair cash value, effective January 1, 1966, the court of appeals has ruled. The ruling uphold section 172 of the Kentucky Constitution which requires a property be addressed at 100% of value for taxing purposes. The decision came in two cases filed by Jefferson County educators, Citizens and students asking for cash value assessments. The Appellate Court reversed Franklin Circuit Judge Henry Meigs, who had thrown out the two cases. Commissioner Watson Clay wrote the Appellate opinion, which ends in a decline in tax assessments. the state average has fallen to about 27% of cash value.

She added Steven's grandmother was a first cousin of her late husband, frank. Just last month she had visited Steven's mother in Louisiana and had dinner with him and his family at their home. She stated that Steven and his father are in the manufacturing business, making Machinery to harvest sugar cane. After seeing her cousin interviewed on television Monday night, Mrs route said it was

nice to know that they are alive. Steven's wife was also

interviewed in paris.
