KSP to conduct statewide driving permit tests Aug. 2

Kentucky To Offer Second Saturday, Aug. 2; Over 1,300 Appointments Available

Have required documents when scheduling begins July 18

FRANKFORT - Team Kentucky will once again offer a statewide event on Saturday, Aug. 2, to help interested Kentuckians obtain their permit. Appointments are available to all Kentuckians who are eligible to apply. According to state law, applicants must be at least 15 years of age to apply.

"Ensuring all new drivers are able to take the first step toward safe, independent driving is another way we protect our roads and communities," Gov. Beshear said. "Team Kentucky has been working to create more opportunities for eligible Kentuckians to get their permit in a reasonable timeframe, and I hope folks are able to take advantage of this statewide event on Aug. 2 to sign up and study beforehand.'

More than 1,300 written permit Statewide Permit Testing Event test appointments will be available on Aug. 2 between 8 a.m. and 4 p.m. at 12 locations, which include Bowling Green, Burlington, Catlettsburg, Elizabethtown, Frankfort, Independence, Jackson, Lexington (Leestown Road), Louisville (Bowman Field), Maysville, Morehead and Pikeville. Applicants can take the test at any of the 12 counties offered. The Kentucky State Police (KSP), which administers state driver testing, will release the appointments on Friday, July 18, beginning at 2:00 p.m. EDT through the online scheduling portal. This one-day event does not include road skills or CDL

In May, KSP and the Kentucky Transportation Cabinet (KYTC), which issues the permit license to applicants who pass the written test, held the first statewide testing event, where 1,104 permit tests were administered.

To ensure a smooth and fair scheduling process, Kentucky State Police Driver Testing Captain Chris Baker said those seeking appointments should prepare necessary documentation and understand that any appointments made using false information or multiple entries under the same name will automatically be canceled. All applicants are asked to provide accurate information when signing up for a slot.

"We want everyone to have a fair shot at securing an appointment," Capt. Baker said. "Before logging in, please have the required documents and personal details ready. That preparation will help avoid errors and delays in scheduling.'

All permit tests must be scheduled through the KSP's

Study the Kentucky Driver Manual, which can be found here. Should an applicant not pass the written test, they can schedule another appointment using the online portal.

On Aug. 2, KYTC Driver Licensing Regional Office staff will also be on-site to issue permit licenses to those who pass the written test. The other regional offices will be open from 8 a.m. to noon for all licensing services as part of the once-a-month Saturday hours.

"Whether it's permit testing or license such as birth certificate (not a renewals at one of our 34 regional offices, we are offering more options than ever to make the process faster and more flexible."

> The Governor signed House Bill 15 into law on March 25, which allows 15-year-olds to obtain their permit. As of mid-July, more than 17,000 15-year-olds have earned their permit. State law still requires you to be 16 years old to obtain an intermediate license. Survivors should keep their contact information updated with FEMA as the agency may need to call to schedule a home inspection or get additional information.

ORDINANCE #2025-3
AN ORDINANCE OF THE ANDERSON FISCAL COURT RELATING TO STREET-LEGAL SPECIAL PURPOSE VEHICLES

WHEREAS, 2025 Ky. Acts ch. 89 (hereinafter "the Act") became law on March 26, 2025 and allows for the operation of street-legal special purpose vehicles on certain highways within the Common wealth of Kentucky if allowed by ordinance of the local government within whose jurisdictiona boundaries the highway is located; and WHEREAS, the Act becomes effective on Friday, June 27, 2025; and

WHEREAS, the Anderson County Fiscal Court has determined that it is appropriate to allow the operation of street-legal special purpose vehicles on specified highways within the jurisdictional boundaries of Anderson County in accordance with the Act and this ordinance. NOW, THEREFORE, BE IT HEREBY ORDAINED by the fiscal court of county of Anderson, Com-

nonwealth of Kentucky as follows: **SECTION ONE DEFINITIONS:** The definitions set forth in Section 1(1) of the 2025 Ky. Acts ch. 89 (hereinafter "the Act"), and as may be amended in the future by the Kentucky General Assembly, are adopted and

incorporated by reference as if set forth fully herein. SÉCTION TWO **DESIGNATED HIGHWAYS:** Street-legal special purpose vehicles shall be allowed to the extent permitted by the Act on all highways that are located within the jurisdictional limits of Anderson

SECTION THREE

EXCEPTIONS: Street-legal special purpose vehicles shall not be allowed to operate:

(a) On any highway, or portion thereof, located within the jurisdictional limits of Anderson County

inless allowed by this ordinance. (b) On any highway, or portion thereof, that is a controlled access system, including but not limited o an interstate or parkway; or

(c) On any highway, or portion thereof, where the United States Department of Agriculture prohibits pecial purpose vehicles.

SECTION FOUR

PROHIBITIONS:

a) Street-legal special purpose vehicles are prohibited from traveling a distance greater than twenty 20) miles on a highway displaying centerline pavement markings.

b) Minitrucks shall not be operated as street-legal special purpose vehicles on a highway that has péen constructed pursuant to a federal highway program.

EFFECTIVE DATE:
This ordinance shall be in full force and effect from and after its passage, approval, attestation, and ublication as required by law.
