## Summer recipes for preserving

have perfected my preservation techniques when it comes to a bumper crop of some of our favorite garden vegetables.

recipes allow us to freeze or can that which we cannot manage to eat or give away while fresh. Here are a few of my favorite recipes.

Some simple

#### **SOFREGIT**

Sofregit is a staple in many Spanish cooking recipes, and it has become my favorite way to preserve bushels of tomatoes from the garden. It is super easy and the flavors are so concentrated you would swear that someone put sugar in it. All you need are onions, tomatoes, a little olive oil and some slow cooking time in a pot. Heat your pot and add some olive oil to cover the bottom, sauté onions until translucent and dump in your peeled (I do not always peel them!) and chopped tomatoes. Cook at a low simmer, stirring occasionally, for several hours until the consistency is just short of a paste. You can freeze sofregit in containers or can it in a hot water bath as you would tomatoes. You can also add a little of your favorite aromatic herb although the straight ver-

sion is my favorite. Use later with pasta, shrimp or just good homemade bread.

#### **PISTOU AND PESTO**

Pistou is the French version of the better-known Italian pesto. I use the term pistou loosely because I use any herb. A pistou in France is just garlic, basil and olive oil. I use the simple technique with garlic scapes and leafy herbs like

basil, parsley and cilantro (but do not limit yourself with just these). A classic pesto combines 2 cups fresh basil, 4 garlic cloves, 1 cup pine nuts, 1 cup olive oil, 1 cup grated parmesan cheese, ¼ cup grated romano cheese and a dash of salt and pepper. Use a food processor to combine the ingredients, adding the oil slowly as you process. Add the cheese and salt and pepper at the end, pulsing several times to complete the mixture. Do the same with your pistou, just with fewer ingredients. Pistou and pesto can be frozen in ice trays first and then package as single servings, or in small glass jars. Its best use is on pasta but be creative!

#### **ZUCCHINI BREAD**

This is probably the best way to get kids to eat zuc-

chini! There are many recipes for zucchini bread and my sister and I have settled on this one as our favorite. Grease and flour 2 loaf pans and pre-heat oven to 350 degrees. In one bowl mix 3eggs, 2 cups of sugar and 1 cup of vegetable oil. In another bowl, mix 3 cups all-purpose flour, 1 tsp. baking soda, 1 tsp. salt, 1 tablespoon cinnamon, ½ tsp. backing powder. Add 2 cups shredded zucchini and ½ chopped nuts to the dry mixture, mix. Then add the wet mixture. Bake for 50 to 60 minutes.

make up the seasoning for many French Provencal dishes and once you have tasted the combination you get addicted. It is a fabulous herb accompaniment to roasted zucchini in its fresh state, but you can also dry the herbs for winter cooking. Herbs are best harvested for drying just as the flowers form but before the buds actually open. Their essential oils are at their peak so the herbs' distinctive flavor will be, as well. Harvest bunches of thyme,

rosemary, lavender and summer savory; hang them upside down in a well-ventilated location. After about two weeks they should be ready to process into airtight jars (be sure they are completely dry or mold may form in the jars. Take a sheet of news paper and roll the herb mixture in the paper to remove the leaves from the stems, pick out the stems and funnel into the jar. Voila, herbes de Provence for later.

All of our garden vegeta-

bles can be frozen, but you first need to blanch then in a hot water bath for about 2 minutes to stop enzyme production in the vegetable. 2 minutes in an ice bath after blanching will quickly cool the vegetable, so it doesn't get over cooked. Let them drain and dry before packaging in freezer bags or containers. Frozen vegetables are great for winter soups and stews.

**ORDINANCE #2025-3** AN ORDINANCE OF THE ANDERSON FISCAL COURT
RELATING TO STREET-LEGAL SPECIAL PURPOSE VEHICLES

WHEREAS, 2025 Ky. Acts ch. 89 (hereinafter "the Act") became law on March 26, 2025 and allows for the operation of street-legal special purpose vehicles on certain highways within the Commonwealth of Kentucky if allowed by ordinance of the local government within whose jurisdictional

boundaries the highway is located; and WHEREAS, the Act becomes effective on Friday, June 27, 2025; and

WHEREAS, the Anderson County Fiscal Court has determined that it is appropriate to allow the operation of street-legal special purpose vehicles on specified highways within the jurisdictional boundaries of Anderson County in accordance with the Act and this ordinance.

NOW, THEREFORE, BE IT HEREBY ORDAINED by the fiscal court of county of Anderson, Com-

monwealth of Kentucky as follows: **SECTION ONE** 

**DEFINITIONS:** The definitions set forth in Section 1(1) of the 2025 Ky. Acts ch. 89 (hereinafter "the Act"), and as may be amended in the future by the Kentucky General Assembly, are adopted and incorporated by reference as if set forth fully herein SECTION TWO

DESIGNATED HIGHWAYS: Street-legal special purpose vehicles shall be allowed to the extent

permitted by the Act on all highways that are located within the jurisdictional limits of Anderson

### **SECTION THREE**

**EXCEPTIONS:** Street-legal special purpose vehicles shall not be allowed to operate: (a) On any highway, or portion thereof, located within the jurisdictional limits of Anderson County unless allowed by this ordinance. (b) On any highway, or portion thereof, that is a controlled access system, including but not limited

to an interstate or parkway; or (c) On any highway, or portion thereof, where the United States Department of Agriculture prohibits special purpose vehicles. SECTION FOUR **PROHIBITIONS:** 

(a) Street-legal special purpose vehicles are prohibited from traveling a distance greater than twenty

(20) miles on a highway displaying centerline pavement markings.
(b) Minitrucks shall not be operated as street-legal special purpose vehicles on a highway that has been constructed pursuant to a federal highway program

**SECTION FIVE EFFECTIVE DATE:** This ordinance shall be in full force and effect from and after its passage, approval, attestation, and publication as required by law.
