

How Will the Passing of Senate Bill 63, Special Equipped Vehicles, Affect Butler County

On June 27, 2025, Senate Bill 63 was passed, making it legal for off-road vehicles to travel on KY highways. Up to this date, off-road vehicles have not been allowed to use public roads. These are now referred to as specialpurpose vehicles, ATVs, and Side by

Be aware that local governments can prohibit the use of street-legal SPVs (defining SPVs as specially equipped ATVs, UTVs, and other special-purpose vehicles) within their jurisdiction.

If you live in the county and own one of these vehicles, you will need to have them inspected in order to ride them on the roads here and in other places. Inspections will be done by the Sheriff's Office and the County Clerk's office will issue the license plates. The City of Morgantown has not addressed this situation yet, so you can not ride them in the city

limits.

There are some regulations and limits imposed on these vehicles. Mopeds are not included in the description, nor are motorized bicycles. The following will be required along with registration and insurance; one or more headlamps, one or more tail lamps, one or more brake lamps, a trail lamp or other lamp constructed and placed to illuminate the registration plate with a white light, one or more red reflectors on the rear of the vehicle, an amber electric turn system, one on each side of the front of the vehicle, an amber or red electric turn signals, braking system, other than a parking brake, a horn or other warning device, a muffler, rearview mirrors on the right and left side of the driver, windshield, unless the operator of the vehicle wears eye protection while operating the vehicle, speedometer, illuminated for nighttime operation, a seat designed for passengers; and tires that have at least two thirty-seconds (2/32) of an



inch or7 greater tire tread. Vehicles cannot be ridden more than a distance of 20 miles. Vehicles must be equipped with a roll bar or roll cage and seatbelts, as required by federal motor vehicle safety standards; this excludes vehicles primarily engaged in farm or agricultural activities. Lastly, vehicles must be inspected by a certified inspector before submission of an application for a title. There is a long list of who qualifies and who doesn't, so check beforehand if you plan to license and insure your vehicle.

agreement, Butler County Tourism financial statement, 1st District Volunteer Fire Department financial statement in the amount of \$205,600 balance, MOA for resurfacing Grancer Road in the amount of \$628,000, Public Assistance grant for Feb. floods reimbursement in the amount of \$133,000, litter abatement payments, financial statement for 2024-25, hazard mitigation for BRADD Administration Cost for Butler County Road stabilization project contract, Rochester monthly bills in the amount of \$786.70, fourth quarter treasurer's report, monthly treasurer's report, transfer \$20,000 from general fund to 911 fund, transfer \$70,000 from General Fund to Jail fund, (this is larger due to holiday causing two payrolls falling into the same time frame), and all other bills and transfers with the exception of check #3917 to be stricken as this was a over payment.

involved were veterans who were pulled into the scam. There was a veteran who was a police officer. There was a veteran who was an airline pilot. There was a veteran who was with the Department of Homeland Security, and several more. They even dragged a wife, mother and sister into the

fraud. In exchange for cash upfront, the veterans were all able to receive high disability ratings after being told what to put on their paperwork and what to say during medical exams.

Of course they're all going to pay. Some of them, if convicted, could get up to five years in prison, and some could receive up to 20 years if convicted of the crimes that included mail

and wire fraud.

Remember: You never have to pay for help in filing for benefits. You never have to give someone a percentage of what you get. Free help is available from various Veterans Service Organizations such as the American Legion, the Veterans of Foreign Wars and even the VA itself. Don't let yourself be used in a scam
