#### SUMMARY ORDINANCE #2025-2

AN ORDINANCE OF THE CITY OF BARBOURVILLE, KENTUCKY AMENDING ORDINANCE NO. 2012-7, "FOR PAWN BROKERS, SECOND HAND DEALERS, PRECIOUS METALS DEALERS, USED FIREARMS DEALERS AND GEMS DEALERS"

WHEREAS, the City Council of the City of Barbourville, Kentucky has determined that the interests of the City of Barbourville and the citizens of Barbourville, KY would be best met by repealing the current ordinance and replacing it with a newly enacted ordinance relating to pawn brokers, second hand dealers, precious metals dealers, used firearms dealers and gems dealers within the City Limits of Barbourville, Kentucky, and

WHEREAS, the city agrees that recommendations to <u>repeal</u> <u>amend</u> current standards set by Ordinance #2012-7 and enact new standards for the protection of the best interest of the citizens of Barbourville, Kentucky, and

Ordinance to have certain inclusions not previously specified, and to enact an Ordinance to better protect the

WHEREAS, the City Council desires to repeal amend previous Ordinance #2012-7, believing such

interests of the city and the citizens of the City of Barbourville, Kentucky,

NOW, THEREFORE, BE IT ORDAINED BY the City Council of the City of Barbourville, Kentucky, such

Ordinance #2012-7 is hereby repealed, and replaced amended with the following changes;

Any person, business or partnership wishing to obtain a license under this ordinance must meet the following requirements:

- Obtain a criminal history background check through the Kentucky State Police for any and all employee(s) and provide all to the Barbourville Police Chief or designee.
- Provide the names, birthdates, Social Security Numbers, and physical addresses of all employees within 3
  business days of beginning employment to the Barbourville Police Chief or designee.
- 3. Provide, in writing, any, and all website(s), web address(es) or auction sites belonging to or operated by or in connection with the business.
  - Provide proof of a bond for \$5,000.00 to the chief of Police
- 5- (4) Pay an annual licensing fee of \$1,000.00 to the City of Barbourville Police Department. The initial license may be pro-rated for any new business. The license fee will be pro-rated based on the month the license is obtained.
- Owners of any business operated under this ordinance shall undergo a background investigation every two
  years.

Any individual, business, LLC, corporation, partnership, or other entity wishing to do business in a manner addressed in this ordinance shall enter into an agreement with the City of Barbourville and Barbourville Police Department to abide by all regulations set forth in this ordinance.

#### Regulations

Licensing fees shall be paid by July 1<sup>st</sup> each year. Licensing fees shall be pro-rated for the time period this
 Ordinance is enacted until July 1<sup>st</sup>.

- Any and all items purchased must be held in a secure location 14 days prior to being offered for sale or trade.
  - 5 Any and all precious metals, gems or collectible currency must be held in a secure location a minimum of 21 7 days prior to being offered for sale or trade.
  - 6 Any business or individual operating under this ordinance must maintain uninterrupted video of the business area for no less than 90 7 days and make any such video available to law enforcement upon request.
- 7 Effective the date this ordinance is enacted any and all items received in any manner must be entered into inventory as it is received, with the exception of new items bought from a wholesaler.
- 8 Any pawn shop, pawn broker, second hand store, precious metals dealer, used firearms dealer or gems dealer located in the City of Barbourville, KY shall not process, file, complete or in any way assist any person or business not currently employed by the pawn shop, pawn broker, second hand store, precious metals dealer, used firearms dealer or gems dealer with the preparation, or filing of state or federal income tax.
- 15. Any business subject to this ordinance that accepts credit or debit cards shall supply the Barbourville Police Chief or designee with a monthly report showing all debit and credit card transactions, amount of purchase and first eight digits of debit or credit card number.

Any person, business, LLC, corporation, or partnership wishing to do business in the city limits of Barbourville, KY as a pawn shop, pawn broker, second hand store, precious metals dealer, used firearms dealer or gems dealer:

any individual or group of persons which have been convicted of, pled guilty to, entered a plea of no contest, entered an "Alford" plea, or otherwise have been found in a court of law to have committed a felony, a misdemeanor crime involving a deadly weapon, a crime of domestic violence or any hate or discriminatory crime that involved a weapon; a person with an active Emergency Protective Order, Domestic Violence Order or other types of Restraining Orders relating to firearm or deadly weapons.

Any pawn shop, pawn broker, second hand store, precious metals dealer, used firearms dealer or gems

1. Any business that buys, sells, trades or otherwise deals in firearms or deadly weapons shall not employ

- dealer located in the city of Barbourville, KY shall not accept a credit or debit card issued to an individual or person for the purpose of receiving Government Benefits, including but not limited to; Social Security benefits, Disability benefits, Welfare, Food Stamps, WIC, Income tax refunds or any other funds issued to a private party by a government entity. Violation shall result in 15 day suspension of license and \$2,500.00 fine.

  3. Shall not provide to customers cash from credit or debit cards, and shall only use a credit or debit card for
- the purpose of a credit or debit transaction to purchase an item or pay the loan on an item. For the purposes of this section the holder of the card must be present and must submit to such transaction. No credit or debit card of any type may be held on the premises of the business for any time other than to swipe or scan the card and immediately return it to the holder, or to hold a card reported as stolen or fraudulently used until law enforcement can arrive to investigate or seize the card. Any business to which this ordinance applies shall not install, maintain or allow the placement of an ATM machine on the premises. Violation shall result in 15 day suspension of license and \$2,500.00 fine.
- Shall not allow a customer's account to exceed \$750.00 for any reason or for any one—item other than a
  motor vehicle, motorcycle, ATV, boat, precious metals, gems, firearms or construction equipment.
- Shall not allow a customers account to exceed \$1,500.00 in total for all items held, except items listed above.
- Shall not operate a check cashing or deferred deposit business on the same premises as a pawn shop.
   Shall not cash personal, business, payday, Income tax Return, Cashiers or travelers checks.
