Our first ancestor Stephen Golden born 1766-67 in Georgia came to Knox County Kentucky by 26 February 1806 as he and his wife Hannah Helms were welcomed into the Arm of the Popular Creek Church that date. He traveled to Kentucky with his siblings, brothers: Edmond Golden born 1778 married Mary Hillar "Polly" Cheshire in Knox County, Kentucky before their move to Clay County, Illinois; Thomas

Lowe Golden born 1790 married Mary Hall and later moved to Crawford County, Indiana. Sisters: Nancy Golden born 1771 married George McFarland and they had a large family on Stinking Creek, Knox County, Kentucky of 9+; sister Elizabeth "Betsy Golden born 1791 married (?) and had one known son William Golden born 1807 (no additional information); sister Sally "Sarah" Golden born 1794 married Alex-

ander Mackey and raised a family of 7 in the Mackey Bend area of Knox County, Kentucky and the youngest known sibling was Winnie Golden born 1774-75, she married Moses Messer; they raised a large family of 9+ on Stinking Creek, Knox County, Kentucky.

Stephen and Hannah Golden raised a family of nine known children. The children began to spread from Golden Creek by the mid 1800's to other areas of Kentucky.
