#### AN ORDINANCE ADOPTING THE CITY OF BARBOURVILLE, KENTUCKY ANNUAL BUDGET FOR THE FISCAL YEAR JULY 1, 2025 THROUGH JUNE 30, 2026

WHEREAS, an annual budget proposal and message have been prepared and delivered to the legislative body; and

WHEREAS, the legislative body has reviewed such budget proposal and modifications have been made accordingly.

NOW, THEREFORE, BE IT ORDAINED BY the City of Barbourville, Kentucky as follows:

SECTION ONE: The annual budget for the fiscal year beginning July 1, 2025 and ending on June 30, 2026 is adopted as set forth herein:

SECTION TWO: This budget ordinance shall be administered by the executive authority as prescribed and set forth in the Kentucky Revised Statutes. Administration shall include, but not be limited to at least the following:

- A. Preparation and submission of financial statements which include budgetary comparisons on a monthly basis.
- B. Provide for budget amendments if requested by the legislative body or if anticipated through administration and implementation.
