The State of Tennessee, Department of Children's Services has filed a petition in Hamilton County Juvenile Court, seeking to terminate the parental rights of Christina Burton Pyburn a/k/a Christina Dawn Crockett to the children, Kelsey Marie Pyburn,

b. 5/27/2013, Luke John Crockett, b. 1/14/2016, and Davi Jean Crockett, b. 11/24/2017. A trial in this case is set for July 16, 2025, at 9:00 a.m. Christina Burton Pyburn a/k/a Christina Dawn Crockett must appear before this Court on that date to determine whether her parental rights to the subject children should be terminated and forever ended. The Court is located at 1600 E. 3rd Street, Chattanooga, TN 37404.

If Christina Burton Pyburn a/k/a Christina Dawn Crockett does not come to the trial, the state will ask the Court to allow it to proceed without contest. That means that the state will ask the Court to let it present proof without having any lawyer appear and defend Christina Burton Pyburn's a/k/a Christina Dawn Crockett's rights in Court.

Any appeal of this Court's final disposition of the complaint or petition for termination of parental rights will be governed by the provisions of Rule 8A, TRAP, which imposes special time limitations for the filing of the transcript or statement of evidence, the completion and transmission of the record on appeal, and the filing of briefs in the appellate court, as well as other special provisions for expediting the appeal.

You may obtain a copy of the Petition and any subsequently filed legal documents or hearing dates in the Juvenile Court Clerk's Office at the address shown above. This will constitute appropriate service on her for all future filings in this case.
