During its regular monthly meeting, the Knox County Board of Education reviewed district facility updates, approved financial and personnel actions, and advanced several agreements, including the renewal of a gym lease with Lynn Camp Baptist Church and travel requests for Lynn Camp DECA students.

The regularly scheduled Knox

County School Board meeting began with the pledge of allegiance by young students from Dewitt Elementary, followed by a prayer from Ralph Halcomb from Artemus Baptist Church.

In reports to the board and updates from the architect on current and future projects, Superintendent Jeremy Ledford shared that the facilities are beginning to be in really great shape, and the transportation department,

RECC, and Barbourville Utility Company have been hard at work to help keep all facilities safe and in great condition.

Ledford stated, "Mr. Barton has done a fantastic job in changing the look of our district. He has great maintenance workers who keep our district running." The recent HVAC system up-

proved the renewal of the gym lease agreement with Lynn Camp Baptist Church for extracurriculars, two out-of-state trips for Lynn Camp DECA students to Arlington, Virginia, and St. Augustine, Florida, from March 6, 2026, to March 10, 2025, and a settlement agreement and general release for previous damage to a bus by a parked car, with damages totaling out at \$1,547.91.

keep Trick or Treaters safe: Decorate Costumes and bags with reflective tape or stickers

Costumes should consist of light

- Masks can obstruct a child's vison, use face paint and make-up whenever
- Costumes should be the right size to prevent trips and falls
- Carry flashlights or glow sticks
- Look left and right and left again
- Do not use electronic media devise, keep heads up and walk, don't run
- Watch for cars that are turning or

Parents can also add to the safety of their children by:

- Providing adult supervision during trick or treating
- Do not allow kids to accept treats that are not commercially wrapped
- Do not allow kids to eat any treats, until they have been inspected

Drivers should also help keep kids safe

Take extra time to look for kids at
