

Weekly Recipe: Stupid Pie



2 can sweetened condensed milk 1/3 cup lemon juice 1 cup powdered sugar 1 cup.chopped pecans 1 tub Cool Whip 1 Graham Cracker Pie Crust

milk and lemon juice until combined. Mixture should thicken slightly 2. Add powdered sugar. Stir in powdered

sugar until smooth, no lumps. 3. Fold in pecans and whipped topping; gently fold in chopped pecans and thawed whipped topping until combined.

4. Fill the crust. Pour mixture into the Graham Cracker Crust and smooth the top with spoon or spatula.
5. Chill the pie; refrigerate for 2–3 hours until

filling is firm.

Kentucky homeowners and renters who suffered uninsured or underinsured damage to their property from the February Severe Storms, Flooding and Straight-line winds now have a few weeks left to apply for federal disaster assistance. FEMA has extended the application deadline to Monday, May 25, 2025.

FEMA assistance for individuals affected by the severe weather can cover rental assistance, temporary housing, home repairs, personal property losses and other disaster-related needs not covered by insurance. FEMA grants do not have to be repaid. FEMA assistance is nontaxable and will not affect eligibility for Social Security, Medicaid or other federal benefits. Call the FEMA Helpline at 800-621-3362. If you use a relay service, such as Video Relay Service (VRS), captioned telephone, or other service, give FEMA your number for that service.

Disaster Recovery Centers are physically accessible to people with disabilities and others with access and functional needs. They are equipped with assistive technology and other resources to help ensure all applicants can access resources.

## FEMA Extends Deadline for Kentuckians

If you were impacted by the February severe storms and live in Breathitt, Clay, Estill, Floyd, Harlan, Johnson, Knott, Lee, Leslie, Letcher, Martin, Owsley, Perry, Pike, Simpson, or Woodford counties, and haven't yet applied for FEMA assistance, FEMA has extended the application deadline to Monday, May 25, 2025.

### Deadline to apply Monday, May 25.

You can visit a Disaster Recovery Center (DRC) to meet face to face with specialists from FEMA to get assistance filling out your application.

- Current phone number
- Address at the time of the disaster
- Address where you are now staying
- Social Security number
   General list of damage and losses
- General list of damage and losses
   Banking information if you want direct deposit
- If insured, the policy number or the agent
- and/or the company name
