The late Joanne Dunaway honored at the May Beattyville City Council Meeting

The Beattyville City Council met in regular session on Monday, May 12, 2025. The meeting was called to order by Mayor Scott Jackson. Sally Gilbert did a roll call. All members were present except for Savannah Mays. Councilman Sam Cockerham gave the opening Invocation. Then all present stood and recited the Pledge of Allegiance. Mayor Jackson welcomed all visitors.

The first thing on the agenda was Resolution 51225 in honor of the late Joanne Dunaway (pcitured) for being a former City Council member and her community service.

The Mayor read the Resolution aloud and then asked for a motion to pass it. A motion was made and carried to approve the Resolution. All council members in attendance signed a Resolution honoring Joan Dunaway for her years of hard work, compassion, service and dedication to the City of Beattyville.

Mayor Jackson said that Paul Nesbitt from Nesbitt Engineering was here earlier today. He brought a structural engineer and they checked the WPA Building. They took out a bearing wall to see what needs to be done. The load bearing wall that was removed is causing the truss to sag. They will get back with us no later than Thursday. "He is going to see if Bob Perkins' crew or whoever done that will do it, if not we will put it out and get somebody to do it," said the mayor.

Mike Smith from KRADD gave his report. "I don't have anything major, just a few quick things. We have most of the AMLER applications wrapped up today. Over the last couple of weeks we have gotten a few of those submitted for you all. We submitted an AMLER for \$2 million for the Mercantile Hub. The update on the Waste Water Treatment Plant Rehab - on the application for the CDBG that was submitted back in January-the Department for Local Government came back with some questions, so that is a pretty good indication that they will fund it.We als submitted an AMLER for the Crystal Creek Trailhead. We submitted a Land and Water Conservation Fund Grant for the Beattyville Outlook. On the Water Treatment Plant Phase 2, I am working on the environmental review for that - the state preservation office is being a little slow with me on that one. As soon as that is out of the way, the environment can be wrapped on that," said Mike.

"There was no one at the meeting from the Small Business Disaster Relief. There is supposed to be someone here tomorrow and they will be all around town. They don't want anyone around. They will be going to the City Park by themselves. From there, they are going to the WPA Building with Bob Perkins. Then they are going to the Farmers Market with Teresa Mays. From there, they are going to the Ambulance Garage with Blake and then to the Town Square. They will then be at the Mayor's office last," informed the mayor.

The Resurrection Home presented to the council their reasons for asking for some of the Opioid Settlement Funds. "You all don't know me. My name is Charlene Dunaway. I



have a brochure of our program. It is called Grandmothers Helping Grandmothers. We submitted a proposal to Scott (mayor) last year around March about what we would like to do with some of these funds. We worked up a little budget and the amount that Scott gave me on the phone was \$15,000.00 and that is what we based our budget on. This will help supplement some of the things that we are already doing plus it will give us funding to start some new things. Right now in this program, we have around 30 grandmothers enrolled. This is where we try to keep our enrollment. This is what we have doing our budget with. We would like to use this money to increase our enrollment number by 20, so that would bring us up to 50 grandmothers. The 30 that we have right now are raising 46 grandkids. The number of kids will fluctuate because they may bring the child today and then come back and get them next week. We are asking for \$5,500.00 to use to help with our operation costs — supplies, utilities, maintenance costs, etc. (this does not include any kind of salary or anything), \$250 for advertising and \$2,000.00 for our monthly meeting costs, create and coordinate additional age appropriate activities for the grandchildren - with the emphasis on preschool and elementary groups. We like taking them and do, when we have the funding, on field trips. We have been to Berea (cultural center). Some of the kids like going to camp in the summertime. We do provide assistance to them to help pay for their costs for that. Same with the youth sports program— if we have a granny that has her grandchild and they are struggling to pay the cost for uniforms or whatever else, we can help them out with that. We want to participate this year in the Trick or Treat on Main, Ready Fest and different things like that. We want to purchase some promotional materials with our name. That will help us all over and all around with everything that we do. We have a yoga instructor that comes from Hazard and when we have the money, we will do that with her with the grannies - we can do chair yoga and we want to get that started for the grandkids. Yoga has been proven as a mental health healing and we think that is really important. We would also like to purchase some yoga mats, enough to get us started. We want to initiate a Telehealth program for mental health sessions. If you have ever been to Resurrection Home, it is a private place that you can not see from the road. A lot of these kids are dealing with a lot of mental health issues and they will pretty much refuse to go to KRCC or go see the counselor at school because of

the kids in a private location and they can do the Telehealth Mental Health appointments. We want to expand financial assistance to the grandmothers to help with holiday, bereavement costs and other emergencies. These grandmothers, the majority of them, get nothing - no extra funding whatsoever to help with these kids. We like to help them out with Christmas, Easter and Thanksgiving. That is an extra cost on any of us. There may be emergencies that come up throughout the year that we would like to try to come up with the funds. As far as that goes, that is the breakdown of the \$15,000.00 that we are requesting. We do have a regular meeting once a month just for the grannies and if there is something going on, we will try to get them in for another time during the month." The Mayor said "I told them that we would give them \$15,000.00. At the end of the year, just bring us something that shows where you spent the money." Mitch Cornelius made a motion to be a little more generous than the mayor. He made the motion to increase the donation of Opioid Settlement Funds to \$20,000.00 and it was seconded. Glenna Cummins said that she would like to see an application and more people to apply for this. "The money trickled in and we did not have guidelines," said Mayor Jackson. "When we get

Lee County Coroner and the Hub Talks to the Fiscal Court about Looking for **Solutions to County Overdose Deaths**

On May 13th, 2025 the LC Fiscal Court held its regular monthly meeting with all magistrates in attendance.

Solid waste receipts for April 2025 totaled approximately \$53k (+). 435 vehicle or trailer loads of unwanted scrap, debris, garbage or appliances were dropped off during the county Spring clean up held last month at the landfill. This amount equals close to 80 tons excluding metals and filled over 20 rolloffs.
