JAN. 28

Jeffrey Clinton Jenkins pleaded guilty to regulations necessary to implement KRS 150. A charge of entry on land to shoot/hunt/fish/ trap without consent first offense was dismissed. He was fined \$50.

• Matthew A. Sandor, 47, of Liberty, was arrested Feb. 8 for rear license not illuminated, license plate not legible, license to be in possession, failure of owner to maintain required insurance first offense operating a motor vehicle while under the influence of a substance first offense, possession of a controlled substance in the first degree, first offense (methamphetamine), and possession of drug paraphernalia.

According to a citation written by Casey County Sheriff's Deputy Jacob Atwood at around 8 p.m. he was observing traffic on Dry Ridge Road when a 2007 Ford F150 passed by without a worked rear license plate light. Atwood began following the truck and attempted to get the license plate number but couldn't due to a license plate cover that had a glare and water on it making the last two numbers illegible.

Once the vehicle came to a stop, Atwood was finally able to make out the numbers. The license plate returned that the vehicle had a verify proof of insurance status. While following the vehicle, Atwood observed it crossing the centerline several times.

Atwood initiated a traffic stop and made contact with Sandor. He explained the reasons for the stop. Sandor said that it was about the sixth time he had been stopped for the license plate violation.

Atwood requested his documentation and Sandor provided an insurance card that was expired on Feb. 5,

2025, three days earlier. Sandor said that he had left his license at home. Atwood noted that Sandor's pupils were constricted even though it was night time.

Deputy Austin Harris and Liberty Police Officer Holly Necessary arrived. Harris deployed K9 Nitro for a check while Atwood was running Sandor's information. Harris told Atwood that there was a positive alert on the vehicle. Sandor told police to "go ahead and search it."

Meanwhile Atwood asked for Sandor to perform a field sobriety test. Sandor was not able to follow instructions and became argumentative. He was unable to maintain his balance. Atwood believed Sandor was impaired.

Harris searched the vehicle and found a plastic baggie with suspected methamphetamine, and a black plastic box containing two straws and meth residue.

Atwood placed Sandor under arrest and he said that he wanted to see the evidence. Necessary presented the black box and bag to him.

Atwood then transported Sandor to the Casey County Hospital, where he demanded a lawyer present, and would not answer on whether he would take a blood test. Atwood then transported him to the Casey County Detention Center.
