 Amanda L. Noll-Nafee, 37, of Harrodsburg, and Michael S. Hendrickson, 33, of Crab Orchard, were arrested Feb. 21 on Wilson Ridge Road.

Noll-Nafee was charged with possession of a controlled substance in the first degree, first offense (methamphetamine), and possession of drug paraphernalia. She was also wanted on a Mercer County indictment warrant for trafficking in a controlled substance in the first degree, first offense (two or more grams of methamphetamine), and possession of a controlled substance in the first degree fentanyl. Hendrickson was charged with disregarding a stop sign, failure to or improper signal, operating on a suspended or revoked operators license, failure to register the transfer of a motor vehicle, and operating a motor vehicle while under the influence of a controlled substance second offense.

According to citations written by Casey County Sheriff's Deputy Tyler Luttrell, at around noon he was observing traffic on Hopewell Road and pulled out behind a gray Nissan Altima. The vehicle came to the intersection of Hopewell and Wilson Ridge Road and disregarded the stop sign and didn't use a turn signal, pulling into the first driveway on the left.

Luttrell activated his emergency equipment and pulled in behind the vehicle. He made contact with the driver Hendrickson and the passenger Noll-Naffee. Deputy Austin Harris arrived on the scene.

Luttrell asked Hendrickson why he blew through the stop sign and didn't use his signal. He noted that the driver seemed very nervous. Hendrickson said that his brakes weren't good in the vehicle. Luttrell asked him whose driveway he was parked

in and Hendrickson said he didn't know for sure. Luttrell then asked him whose vehicle he was driving, and Hendrickson replied that he was buying the car from someone in Crab Orchard and making payments. He admitted that his license was suspended. Noll-Naffee admitted that she might have a warrant.

Luttrell then ran both of their information through dispatch. While waiting, Deputy Harris deployed K9 Nitro, who gave police a positive alert on the vehicle.

Luttrell asked both occupants of the vehicle to step out and began searching. Dispatch confirmed that Hendrickson's license was suspended and Noll-Nafee was wanted in Mercer County.

Harris located a pink bag on the passenger side floorboard. Noll-Nafee took ownership of the bag. She said there were needles in the bag and told Harris to be

careful. Inside the bag was a container with several needles and a plastic container. Inside the container was a wet cotton swab with suspected meth residue. There was a small box under the center console and inside was a baggie with suspected meth.

Meanwhile Luttrell asked Hendrickson when the last time that he used drugs, and Hendrickson said it had been a while.

Luttrell asked Hendrickson to perform a field sobriety test and he did. Hendrickson had trouble completing the test and following directions. Luttrell believed Hendrickson was impaired and asked Hendrickson to be honest with him. Hendrickson said he had used meth the night prior but he was not high.

Luttrell placed Noll-Nafee under arrest and transported her to the Casey County Detention Center. Hendrickson was transported to the Casey County Hospital. Hendrickson refused

a blood test saying that it would show meth in his system even though he wasn't high. He was then transported to the detention

The suspected meth was sent to the KSP lab for positive identification.
