A measuring stick was below water on March 1 as Lake Liberty is completely full. A wet January and February have contributed to a plentiful water supply this year, as opposed to last year when the City of Liberty announced a near critical level. The water level was at least 13 feet lower than it is today. A funding bill, which includes a \$9 million construction of a companion lake, is advancing through the Kentucky Legislature.
