This all roads lead to heaven philosophy is popular around the world and are appalled that any particular religious group would claim to have exclusive rights to eternal salvation. However, Jesus made this quite clear, “I am the way and the truth and the life. No one comes to the Father except through me.” How can anyone disregard this specific truth and say this means any god, faith, or philosophy? And, does this mean the billions of people who have heard the gospel but refuse Christ as their Lord are lost? We must reject compromising and sugar coating spiritual truth with human opinions. According to the Bible, yes. A feature of the new heaven and earth will be the 2 million square mile glorious city of new Jerusalem where the saints will live with God forever. So, how many

people will be there? First we need to use a calculation system to determine how many people have lived in the last 6000 years since Adam. We will use the young earth as a base for our estimate.
