stating that police had no business there. Harris advised Smith why they were there and said that police were trying to figure out what was going on. Smith continued yelling and cussing, and began to throw things. Harris spoke to a witness who explained the situation. Police then went and spoke to the juvenile, who said that Smith had threatened to bash her head in if she got his kids taken from him. Harris went and spoke to Smith who was still irate and continued to yell and cuss. Smith threw a rubber hose into the back of a truck, and it bounced out and almost hit the officer. Harris told him to calm down and stop. Instead of calming down, Smith turned around and balled his fists and said that they were going to throw hands.

Harris grabbed his arms and shoved him into the back of the truck so he could grab both of his hands and place handcuffs on him. Harris then placed him under arrest and transported him to the Casey County Detention Center.

 Robby P. Price, 41, of Liberty, was arrested May 1 for alcohol intoxication in a public place, and disorderly conduct in the second dearee.

According to a citation written by Casey County Sheriff's Deputy Tyler Luttrell, at around 10 a.m. police were dispatched to a workplace where a man was being disorderly. While en route, the caller stated that people had restrained him. Upon arrival, Luttrell, Liberty Police Chief Steven Garrett, and Sheriff

Chad Weddle made contact with Price who was being held by a few employees of the business. They said that the man was yelling and cussing at a woman. They stated that the woman was leaving and the man went after her so they restrained him. Luttrell went to speak to Price, who was upset that police were there. Garrett placed Price in handcuffs. Price was slurring his words and smelled like an alcoholic beverage. Price kept asking why he was being placed under arrest and had to be told over and over. He was then transported to the Casev County Detention Center.

 James E. Risner, 60, of Liberty, was arrested May 1 for alcohol intoxication in a public place, terroristic threatening third degree, disorderly conduct in the second degree, knowingly abuse/neglect of adult by person, menacing, and assault fourth degree with minor injury.

According to a citation

written by Casey County Sheriff's Deputy Austin Harris, at around 4:30 p.m. he, with Deputy Hannah Adams, and Officer Adam Hewett, responded to a call of a physical domestic disturbance, and arrived to an address on G. Richardson Road. They made contact with a female caller who said that Risner had gotten into a verbal altercation with a male, who she said had an extremely bad diagnosis of autism and was declared disabled. She said that Risner had threatened to break the male's jaw, and had grabbed the male's pinky finger and was twisting it. She tried to break it up and he struck her in the arm with his fist, and

then fled out the front door into the woods. She said that Risner was extremely intoxicated and angry. She showed police the mark on her arm where she was struck. The male victim was upset and showed police his bloody fingernail where Risner had hurt him and made him bleed.

After attempting to locate Risner in the woods, police found him in field. He was manifestly under the influence, unable to stand on his own without losing balance and was slurring his speech, saying things that didn't make sense. The odor of alcohol was very strong. Harris asked Risner what happened and at first he said nothing, but then said he had gotten into an argument so he was walking outside and feeding cows.

Risner was injured and Harris asked what happened, and Risner said that he was injred feeding a bull. Harris asked about the marks on the victims and Risner said he didn't know anything about it, but put his finger in the deputy's face in a threatening

manner. Harris then placed him under arrest and, while waling up a muddy hill, Risner began to pull away. His foot slipped out from his sandal and he fell to the ground. Risner began yelling that the deputy slammed him. Harris advised that he was holding him up due to his level of intoxication. Harris placed Risner in the back of a patrol vehicle and transported him to the detention center. While on the way to jail, Risner stated that he was going to "beat the hell" out of the deputy and that he was coming from him when he got out of jail. While walking into the jail, he continuously yelled and cussed after being told to stop multiple times.
