AN ORDINANCE RELATING TO COMMUNICATIONS SERVICES.

WHEREAS the City of Ferguson ("City") seeks to enact the following ordinance relating to Communications Services so that all Communications Service providers are treated equally and subject to the same rights and obligations when operating

NOW, THEREFORE, BE IT ORDAINED BY THE CITY AS FOLLOWS:

§ 2 FRANCHISE REQUIREMENTS AND CHARACTERISTICS.

§ 1 GENERAL PROVISIONS.

§ 3 RIGHTS-OF-WAY MANAGEMENT AND FACILITIES REQUIREMENTS. § 4 MISCELLANEOUS.

Except as expressly stated in this Ordinance, the express or implied repeal or amendment of the ordinances replaced by this Ordinance or any other ordinance or part thereof shall not affect any liabilities accrued, penalties incurred, or proceedings begun prior to the effective date of this Ordinance. Those liabilities and penalties are continued, and penalties shall be imposed and enforced under the repealed or amended ordinance as if this Ordinance had not been adopted.

THE BONDS SHALL NOT REPRESENT OR CONSTITUTE AN INDEBTEDNESS OF THE CITY, OR OF THE COMMONWEALTH OF KENTUCKY OR ANY POLITICAL SUBDIVISION THEREOF, WITHIN THE MEANING OF THE CONSTITUTION OR THE STATUTES OF THE COMMONWEALTH OF KENTUCKY. The maximum amount of Bonds to be outstanding at any one time is \$100,000,000.
