City Clerk was instructed to re-advertise for bids for construction of concrete curbing-guttering and sidewalk on North Maple Street. An order was entered that the regular sessions would be held at 7:00 p.m. until further ordered, consequently the next session will be at that hour on date of October 12, 1925.



## **STATE NEWS:**

-A passenger airplane service between Louisville and Lexington, running on a regular schedule, will be attempted by the Blue Motor Coach Company of Louisville, it was learned last week when articles of incorporation were filed in the Jefferson county clerk's office. The service will

begin shortly, it is understood. -The number of automobiles is increasing in Kentucky just as it is in every other state in the Union. Last year, at the end of June, there was one car in Kentucky for every 11.9 persons. At the end of June this year there was one for every 10.3 persons, as shown by the latest official enumeration of population.

### **NATIONAL NEWS:**

-America has been branded the most careless nation in the world, in regard to accidents, by delegates gathering from over the world to the fourteenth annual Safety Congress. ... It is pointed out that the accidental death rate for the United States is 76.3 fatalities for 100,000 population as against a rate of 33.6 for England and Wales. The safest country in the world seems to be Denmark, where the rate is 20 accidental deaths for each 100,000 population.

-Hollywood is to have a \$2,500,000 club for film folk exclusively. Plans for the new club, which will unite all the leaders of the motion-picture industry, and at which actors and directors will mingle with authors and producers, were revealed with the announcement of the purchase for \$1,000,000 of the famous twelve-acre Bernheimer estate in Hollywood as a site for the club. Another \$1,500,000 will be spent in improvements and developments.

**EDITORIALS:** -Residents of North Main Street are much interested in seeing that permanent street improvements be made in their section. reports show that Typhoid and that men and women prislent in this community, and that there are indications of its further spread, thereby endangering the lives of many people, the State Board of Health by virtue of its authority ... urges that the people of all ages report to their family physician immediately and be vaccinated against this dread disease. Every physician in the community is prepared to vaccinate any who will call upon him. It is further urged that every householder immediately see to the cleaning-up of his premises, getting rid of filth, manure and other breeding places for flies, making all privies fly-proof and sanitary, and protecting all cisterns, wells and springs from the danger of any surface drainage. All homes should be screened against flies, which are constant carriers of filth. It is further urged that all water which has not been tested and pronounced pure and safe by Health Department test be boiled before drinking or used for domestic purposes.
