The Pulaski County Board of Education approved the purchase of a half dozen school buses at Tuesday's October meeting, for a total cost of \$1,007,000.



Pulaski man arrested on federal drug charges

A Pulaski County man is in custody following the execution of a United States District Court Federal Warrant on Tuesday, according to the Pulaski County Sheriff's Office.

The indictment stems from an investigation that in Pulaski County when detectives from the Pulaski County Sheriff's Office Nar-

cotics Division began an residence, detectives located who was was arrested and approximately 131.7 grams of methamphetamine in three separate baggies, marijuana, glass pipes, and over \$1,000.00 in cash, according to the sheriff's office, which added that part of the methamphetamine was located inside of a hidden compartment in the bathroom.

On Tuesday, the Pulaski County Sheriff's Office Narcotics Division located West, transported to the FBI in London on the following charges:

Possession With the Intent to Distribute 50 grams or more of a methamphetamine mixture.

Two arrested on drug charges as result of eastern Pulaski traffic stop

Two Bronston men are in custody following a traffic stop in the Shopville community on Saturday night that resulted in multiple drug-related charges.

The incident began when Deputy Grant Bryant was on Ky. 461 conducting his normal duties when he observed a black Dodge Challenger, with expired registration. The vehicle turned on Old Mount Vernon Road, where Deputy Bryant conducted a traffic stop, according to the Pulaski County Sheriff's Office.

After stopping the vehicle, Deputy Bryant witnessed a Dodge Caliber stop behind him. Bryant observed the driver of the Caliber, Johnathon Welty, 34, of Bronston, change positions with a passenger, Shane Deffenbaugh, 27, of Bronston, according to the sheriff's office.

Deputy Bryant was familiar with Welty and knew he had a suspended driver's

license. Bryant detained that vehicle as well. Deputy Caleb Wesley arrived on scene to assist, along with Deputy Dylan West and his K-9 Rocky.

Deputy West deployed Rocky to conduct a free air sniff of both vehicles. Following the free air sniff, Deputy West determined that K-9 Rocky indicated the presence of illegal substances in both vehicles, according to the sheriff's office.

Deputies conducted a search of both vehicles. Inside of the Caliber, Deputies located approximately 205.2 grams of methamphetamine, and inside of the Challenger, Deputies located marijuana and a syringe inside of a purse, according to the sheriff's office.

The driver of the Challenger, Caitlyn Fragosa, age 31, of London, claimed the items in the purse belonged to her, according to the sheriff's office.
