# Are there shuttles to the Kentucky Derby?

Yes, some hotels will give guests rides on Kentucky Oaks and Kentucky Derby days. Please check with the staff where you are staying.

### How can I get a bus ride to Churchill Downs?

The Transit Authority of River City has offered free bus rides in the past on Thurby, Kentucky Oaks and Kentucky Derby days, but they still have to announce the routes for this year. Check its webpage as it gets closer to the event to see the schedule.

#### Can I ride a rental scooter to Churchill Downs?

No, scooters are not allowed at Churchill Downs or any of the closed roads that lead to the racetrack. Use the rental app to look for an authorized place to park the scooter.

#### Is there handicapped parking at Churchill Downs?

Yes, there are parking spaces available for people with state-issued ADA parking placards and license plates. Like other parking spaces in the reserved lots, ADA spaces are first-come, first-serve.

Individuals who paid impound

fees to Dave's Towing for the

release of vehicles that were

towed and/or impounded from

a private lot by the Defendant

in Jefferson County, Kentucky

from June 11, 2012 to November

16, 2021

### If you paid an impound fee to Dave's Towing Service, Inc. from June 11, 2012 - November 16, 2021, a class action lawsuit may affect your rights.

You may be affected by a class action lawsuit about whether Dave's Towing Service, Inc. ("Dave's Towing") improperly impounded your vehicle.

The lawsuit is called O'Loughlin, et. al. v. Dave's Towing Service, Inc., No. 17-CI-5454, and is in Jefferson Circuit Court. The Court decided this lawsuit should be a class action on behalf of a "Class," or group of people, that could include you. This notice summarizes your rights and

options before an up- coming trial. More information is in a detailed notice available at the website below. If you're included, you have to decide whether to stay in the Class and be bound by whatever results, or ask to be excluded and keep your right to sue Dave's Towing. There is no money available now and no guarantee that there will be.

# ARE YOU AFFECTED?

Individuals who paid impound fees to the Defendant for the release of vehicles that were towed and/ or impounded from a private lot by the Defendant in Jefferson County, Kentucky from June 11, 2012 to November 16, 2021, are Class

## WHAT IS THIS CASE ABOUT?

The lawsuit claims that Dave's Towing violated the Louisville Metro Private Towing Ordinance while impounding vehicles in Jefferson County. The suit claims the Dave's Towing did not obtain proper authorizations for the impounds. It also says that it refused to accept credit card payments despite being required to do so.

Dave's Towing denies that it did anything wrong and asserts that it complied with the ordinance to extent it was possible to do so. The Court has not decided whether the Class or Dave's Towing is right. The lawyers for the Class will have to prove their claims at a trial set to begin on June 3, 2025.

WHO REPRESENTS YOU?

The Court asked Satterley & Kelley, PLLC and Stein Whatley Astorino, PLLC, to represent you as "Class Counsel." You don't have to pay Class Counsel, or anyone else, to participate. Instead, if they get money or benefits for the Class, they may ask the Court for attorneys' fees and costs, which would be paid by Dave's Towing or out of any money recovered, before giving the rest to the Class. You may hire your own

lawyer to appear in Court for you; if you do, you have to pay that lawyer. Scott O'Loughlin and Stefan Gearhart are Class members like you, and the Court accepted them as the "Class Representatives."

# WHAT ARE YOUR OPTIONS?

You have a choice of whether to stay in the Class or not, and you must decide this now. If you stay in the Class, you will be legally bound by all orders and judgments of the Court, and you won't be able to sue, or continue to sue, Dave's Towing-as part of any other lawsuit—for improperly impounding your vehicle from June 11, 2012 to November 16, 2021. If money or benefits are obtained, you will be notified about how to get a share. To stay in the Class, you do not have to do

If you ask to be excluded from the Class, you cannot get any money or benefits from this lawsuit if any are awarded, but you will keep any rights to sue Dave's Towing for these claims, now or in the future, and will not be bound by any orders or judgments of the Court. To ask to be excluded, send a letter to Satterley & Kelley, PLLC, 8700 Westport Road, Ste. 202 Louisville, KY, 40242 postmarked by May 15, 2025, that says you want to be excluded from O'Loughlin, et. al. v. Dave's Towing Service, Inc.. Include your name, address, telephone number, and the date location of your impound(s). You may also complete an opt-out form at the website below.
