The Louisville Metro Air Pollution Control District (District) proposes to renew an operating permit to Louisville Gas & Electric Company, Cane Run Generating Station (power plant), 5252 Cane Run Road, Louisville, KY 40216, in accordance with Regulation 2.16. This permit is being issued to renew Title V operating permit O-0126-25-V and incorporate insignificant activities. The 30-day public comment period starts on September 27, 2025, and ends on October 27, 2025. A public hearing may be scheduled if the District determines that there are germane, unresolved issues or substantial public interest, in accordance with Regulation 2.07. Drafts of the permit and summary are available at the District office, 701 W.
