#### **ORDINANCE NO. 367. SERIES 2025** AN ORDINANCE AMENDING ORDINANCE NO. 220, SERIES 2006, RELATING TO THE LICENSING OF DOGS.

WHEREAS, the Harrison County Fiscal Court has been inormed that the licensing of dogs will no longer be maintained as a matter of state law, and

WHEREAS, the Court wishes to provide for the licensing of dogs in Harrison County, Kentucky, NOW, THEREFORE, BE IT ORDAINED by the Fiscal Court of

the County of Harrison, Commonwealth of Kentucky, as follows: 1. As of July 1, 2004, every owner of a dog in Harrison County, Kentucky will have said animal licensed by the purchase of a license tag. Upon payment, the owner shall be issued a certificate of registration and the license tag(s). Dog license tags must be attached to a collar and worn by the dog at all times. Kennel licenses/certificates shall be posted in a prominent place.

2. Definitions. For purposes of this Ordinance: a) A dog means any canine three (3) months of age or older. b) Designated license facility shall mean any animal control facility, the Harrison County Humane Society, the Harrison County Clerk's Office, or any participating veterinary facility

c) A kennel shall mean any combination of six or more dogs housed or located at one single location.

3. The application for a dog or kennel license shall be accompanied by payment of a fee in an amount as set forth by the Fisc-al Court-an amount of \$7.00 for each dog and \$50.00 for each ennel plus \$3.00 per dog.

4. Each license issued for a dog or kennel shall be effective for a period of one year from the date of issue.

5. In the event a license for a dog or kennel is lost, upon proof and documentation of the lost tag, acceptable to the Animal Con-trol Officer or the designated license facility, said tag shall be replaced at no cost to the licensor.

6. Animal control officers or the designated license facility shall be agents of the County in the collection of license fees. For services rendered by participating private veterinary facilities in collecting and paying over the fee, the vendor shall be allowed to re tain the sum of \$3.00 for each license tag.

7. The balance of the license fee collected shall be paid to the County monthly and shall be maintained by the County Treasurer in an account designated for that purpose.

8. If the County finds it to be in the best interests of the maximum enforcement of this Chapter to permit certain other portions of the license fee to be retained by the animal control officer for use in enforcement, the County may allow these portions of the license fee to be so retained by the Harrison County Animal Con rol Officer

9. The Harrison County Fiscal Court shall employ an animal con trol officer and shall establish and maintain an animal shelter as means of facilitating and administering KRS 258.095 to 258.500. The Court may choose to designate the Harrison County Sheriff's Office to administer KRS 258.095 to 258.500.

10. PENALTIES: Any person violating this Ordinance, unless otherwise indicated, shall upon conviction be fined not more than \$500.00 or confined in a County Detention Center for not more than ninety (90) days, or both, in the discretion of the District Court. Any fines, less the court costs, shall be payable to the Harrison Fiscal Court for the operation of the Flora Shropshire Animal Shelter.

11. This Ordinance repeals all ordinances with reference to animal control and contrary therewith within Harrison County. INTRODUCED AND GIVEN FIRST READING AND APPROV-AL BY THE FISCAL COURT OF HARRISON COUNTY, KEN-TUCKY AT A REGULAR MEETING ON THE 22ND DAY OF APRIL, 2025

GIVEN SECOND READING AND ADOPTED BY THE FISCAL COURT OF HARRISON COUNTY, KENTUCKY AT A REGU-LAR MEETING ON THE 13TH DAY OF MAY, 2025, AND ON THE SAME OCCASION, SIGNED IN OPEN SESSION BY THE COUNTY JUDGE-EXECUTIVE AS EVIDENCE OF ITS AP-PROVAL

THIS ORDINANCE SHALL TAKE EFFECT AND BE IN FULL FORCE AND EFFECT WHEN PASSED, PUBLISHED AND RE-CORDED ACCORDING TO LAW.
