Planning and Zoning discuss cell tower and White Oak Estate

On Monday, Sept 15, the Cynthiana-Harrison County-Berry Joint Planning Commission met for a regular meeting.

After a call to order and roll call, minutes were approved for the previous meeting on Monday, Aug 18.

With no old business to discuss, the meeting went straight into the new.

NEW BUSINESS

-The first item of new business was a lengthy back-and-forth between members of the commission, the public and presenters of a potential cell phone tower at 8279 Ky. Hwy. 32 West, Sadieville, Ky. 40370.

Keith Brown with Pike Legal Group spoke to the commission to present details on the cell tower application.

are Verizon Wireless and a company called The Towers LLC., who will construct the tower for Verizon's antennas.

"We filed all of the exhibits that are required by the Kentucky revised statutes," noted Brown. "We think followed all of the procedural guidelines...'

Mr. Brown stated that "Harrison County deserves great cell coverage in as many areas as possible. We think we're going to improve your coverage, so we thank you for listening to me and we ask for your approval..."

On Tuesday, Sept 16, the Cynthiana Board of Commissioners met for their second and final regular meeting of the month.

Mayor Isaac Dailey kicked things off with starting a discussion about street legal special purpose vehicles on public roadways. Mayor Dailey noted that it's an ordinance that mirrors an ordinance passed by the county several weeks prior.

With no one in attendance to participate in discussion, Mayor Dailey noted that another public discussion would happen at the next meeting to allow the public enough time to give feedback.

VISITORS

-Garnett Furnish attended the meeting and addressed the Board to give an update on the Economic Development Authority.

Furnish works with business retention and attraction and workforce development, working very closely with industry in our community. Furnish is an employee of the economic development authority.

UPDATES INCLUDED

-Occupational taxes are showing an increase from last year.

-The business park has 40 acres left to be developed. -CSTH, or E-Z Pak, plans to open

the new plant on Oct 1. They'll add about 50 new jobs and are keeping the old plant in operation.

-They removed the fence and trees in from of the new CSTH on New Lair Rd.

-GlenGery Stone is being backfilled by Tri County Lumber.

"You and EDA have been a lot to keep up with in these first nine months," noted Mayor Dailey. "There's been a lot of good progress and projects going on in 2025."

-Mayor Dailey made a motion to approve minutes from the Sept 2 regular meeting, which carried.

LEGALS

-City Attorney John Lair gave a public first reading of Ordinance #1680 - Street Legal Special Purpose Vehicle Usage.

-A discussion was had on 139 East Pike Street proposals of which there were two.

"I think it would be smart of us to have a conversation on what restriction, limitations or expectations we would assign to the sale of the building so that John [Lair] can get something

together for when we move to sell the property," noted Dailey.

An update is supposed to be given at the next meeting.

COMMISSIONER'S REPORTS

 Commissioner of Public Utilities and Works, David Conner, gave an update on the Municipal Road

-Commissioner of Public Property and Finance, Mark Mattmiller, made a motion to play bills: \$89,857 in the general fund and \$118,703 in the water and sewer fund, which carried.

Cash in the bank in the general fund is \$109,517, water and sewer is \$263,394 and municipal road aid fund is \$129,583.

-Commissioner of Police Safety, Taylor Peoples, was not present and thus the report was read by Commissioner Roger Slade.

A motion was made to authorize to accept the resignation of Jeffery Asbury as Police Officer/School Resource Officer effective Sept 30, 2025, which carried.

A motion was made to authorize to use DA Asset Forfeiture Equitable Sharing Funds in the amount of \$2,160 to pay the yearly license fee of the Axon Camera Auto-tagging feature on all the body worn cameras, which carried.
