**2025 Real Property Assessment Roll Open Inspection Period**

In compliance with KRS 133.045, Scott County PVA John Burke announces the **2025 Scott County real property assessment roll will be open for public inspection MAY 5th - 19th** at the PVA office located at the Scott County Courthouse, 101 E. Main St., Room#203, Georgetown, KY 40324. The assessment roll may also be inspected online 24 hours a day at [www.scottkypva.com](http://www.scottkypva.com) or in person from 8:30 a.m. to 4:30 p.m. Monday thru Friday and from 9:00 a.m. to noon on Saturdays, MAY 10th & 17th.

**Assessment Appeal Process**

A property owner who wishes to **appeal** their assessment **must first complete an Informal Assessment Review** with the PVA or PVA deputy in person, or by calling the PVA office at 863-7885 or thru email at [john.burke@ky.gov](mailto:john.burke@ky.gov). **Assessment Review deadline is 4:30 p.m. Monday, MAY 19, 2025.**

If an Informal Assessment Review (completed by 4:30 pm Monday May 19) does not result in agreement, a property owner may appeal to the Local Board of Assessment Appeals by requesting a formal appeal form. Deadline to file Formal Appeal forms must be returned by 4:30 pm Tuesday May 20th.

Property owners dissatisfied with the Local Board of Appeals decision, may appeal to the Kentucky Board of Tax Appeals. Any property owner failing to appear before the local board, will not be eligible to appeal to the Kentucky Board of Tax Appeals.
