Dan Cummins Auto Group earns Governor's Service Award

Dan Cummins Auto Group was presented with the 2025 Governor's Business Service Award Wednesday. The company earned the state's highest award for businesses supporting volunteer efforts in their communities thanks to its ongoing support of CASA of Lexington.

"Since 2017, Dan Cummins Auto Group has been a critical partner of CASA of Lexington, supporting children in the family court system through generous financial contributions and community engagement," said Chip Polston, host of Kentucky Life on KET and the emcee for the 2025 Kentucky Governor's Service Awards. "With more than \$435,000 in donations and widespread promotion of CASA's mission ... they've helped the program expand to seven counties and serve more than 680 children each year. Dan Cummins Auto Group exemplifies the powerful impact of corporate partnerships and strengthening Kentucky communities."

Dan Cummins Auto Group owners Josh and Dusty Cummins accepted the award during the event, held in downtown Frankfort Wednesday. "Dusty and I are honored to continue supporting the volunteers who put faith into action," Josh Cummins said.

CASA volunteers are trained community members who are matched with abused and neglected children in the family court system. They visit the children monthly, identify if any of the children's needs have been overlooked, and advocate for the children's best interests. Each CASA volunteer gives on average 5-10 hours a month. Often, the CASA volunteer is the only per-

son on a child's case who has remained consistent throughout numerous changes.

Former Kentucky House Representative Rocky Adkins, who is a senior advisor to Kentucky Gov. Andy Beshear, attended on behalf of Beshear, telling the Cummins brothers and other honorees they represent the best of Kentucky.

"It's about engaging to make a difference and the impact we may have on just one individual that changes their life forever," Adkins said. "These honorees are more than award recipients, they are shining examples of what it means to be a true Kentuckian — resilient, compassionate and committed to making their communities stronger and a better place."

Melynda Jamison, Executive Director of CASA of Lexington, said the Cummins' financial support and efforts to raise awareness about the CASA mission have helped ensure hundreds more children have received CASA services.

"We have grown the number of children we are helping by as much as 70 percent since the Cummins family first began raising awareness about the problem of child abuse and funding CASA of Lexington so hundreds more children could receive services," Jamison said. "The Dan Cummins Auto Group and its employees have been essential to helping more children and building a stronger future for all of us in central Kentucky."

Dan Cummins Auto Group operates dealerships in three of the seven counties served by CASA of Lexington: Bourbon, Scott and Jessamine. For three years in a row, the auto group has donated at least \$100,000 to CASA of Lexington by

taking a portion of profits from each car sale. The dealerships also promote CASA awareness and host CASA of Lexington's annual events to provide gifts for children in need during the holidays.

Sen. Matt Nunn, R-Sadieville, has been selected to participate in the 21st Annual Emerging Legislative Leaders Program at the University of Virginia's Darden School of Business, a prestigious national initiative sponsored by the State Legislative Leaders Foundation (SLLF). The program identifies rising stars in state government and brings together 57 legislators from 47 states for intensive training focused on public policy, leadership, and collaborative governance.

"This is a well-deserved honor for Sen. Nunn, who came in as a freshman lawmaker, earned broad bipartisan support, and made an immediate positive impact on policy," said Senate President Robert Stivers, R-Manchester. "We look forward to his continued growth as a legislative leader and trust this well-earned experience will serve him and his constituents in the 17th Senate District well."

Nunn's invitation to the SLLF program follows a highly productive first session in the Kentucky Senate, where he championed legislation that

promotes fiscal responsibility, curbs bureaucratic overreach, and reinforces the integrity of public institutions. SLLF is a nonpartisan, nonprofit organization that supports the professional development of state legislative leaders across the nation. Its Emerging Legislative Leaders Program mentors promising first- and second-term lawmakers from all political backgrounds. Through university partnerships and issue-neutral programming, SLLF promotes collaboration, integrity, and respect for the legislative institution, welcoming Republicans, Democrats, and independents alike.

"I remain grateful to the people of my district for trusting me to be their voice in Frankfort. It's not something I take for granted," Nunn said.

"To be among this small group of leaders is an honor, and I'm excited to see how it will help me grow as a lawmaker."

KYTC warns of text message scam alert

The Kentucky Transportation Cabinet (KYTC) is warning Kentuckians of fraudulent text messages impersonating tolling agencies, which feature a suspicious link similar to the KYTC licensing website address.

If you receive one of these texts, do not click the link. Even if the website or link looks like it belongs to KYTC, the text is a scam. KYTC will not send text messages to collect tolls, and we are taking appropriate steps to have the fraudulent websites taken down.

The scam messages warn customers of unpaid tolls, and indicate fees will be incurred if payment is not sent immediately.

If you have provided any personal informa-

tion, contact your bank immediately. You can also report this to the FBI's Internet Crime Complaint Center (IC3) at www.ic3.gov, or to the Federal Trade Commission at www.reportfraud.ftc.gov, or visit the Kentucky Office of the Attorney General website, www.ag.ky.gov, to follow their guidance concerning potential identity theft. You can also forward the suspicious message to 7726 (SPAM) to alert your mobile provider as well.
