2025 PROPOSED TAX RATE PUBLIC HEARING

The Grayson County Fiscal Court will hold a public hearing on August 21, 2025 at 4:30 p.m. at the Grayson County Government Annex for the purpose of obtaining comments from the public regarding the proposed tax rate.

The tax rate levied last year was 6.60 and produced revenues in the amount of \$1,035,761. This year's compensating rate is 6.40 and will produce revenues in the amount of \$1,064,676. The Grayson County Fiscal Court proposes to keep the same tax rate of 6.60 which will produce a total of \$1,097,947 in revenues. Revenue expected from New Property is \$24,896; revenue expected from Personal Property is \$172,765; revenue expected from Motor Vehicle is \$190,340; and revenue expected from Wa tercraft is \$28,535.

Revenue received in excess of last year's revenue will be used for expenses related to general government, protection, general health and sanitation, debt service, and administration.
