# BMWED Warns: Cutting Human Rail

The Brotherhood of Maintenance of Way Employes Division (BM-WED) is raising concerns over a recent effort by the nation's largest freight railroads to reduce human oversight in rail safety inspections. While Association of American railroads claim they need Railroads (AAR) on May 9, 2025, suggest a continwaivers to use Automated Track Inspection (ATI) ued push to reduce hutechnology, the union says the real goal is to scale back the frequency of required visual inspections — a move that could

the national rail network. ATI, also known as Track Geometry Measurement Systems (TGMS), has been used since the 1970s to measure track geometry defects such as gauge deviations. The technology can help detect some issues more consistently than manual methods. However, it cannot identify the majority of track problems that trained human inspectors find — including structural defects, switch component issues, vegetation overgrowth, and vandalism.

Current data shows ATI fails to detect 74% of track defects identified under federal safety regulations. Human inspectors not only assess track conditions visually, but they can also immediately act to prevent accidents by placing slow orders, initiating repairs, and alerting maintenance crews in real time. ATI, on the other hand, sends data to centralized locations for later review, which can delay critical safety responses by up to 72 hours. BMWED supports the

use of ATI as a supplemental tool but firmly opposes its use as a replacement for human inspections. The union points to past waiver petitions filed by Class I railroads, including BNSF

**Inspections Puts Communities at Risk** and Norfolk Southern, which requested relief from visual inspection requirements in areas where ATI was used frequently. These efforts. combined with a newly filed petition from the

man involvement in track

inspections. petition, AARposted under FRA Docket Number FRA-2025-0059, seeks to cut required human visual inspections by more than 75%. BMWED argues this change would lead to

an increase in undetect-

ed track defects and preventable derailments. According to Federal Railroad Administration (FRA) data from 2014 to 2024, 57% of track-related derailments involved defects that only human inspectors could detect. While ATI could have identified the remaining 43%, it is not capable of replacing the full scope of safety inspections man-

dated by law. In October 2024, the FRA proposed a rule that would require railroads to use ATI at regular intervals while maintaining current levels of human inspection. The proposed rule aims to improve safety by combining the strengths of technology with the reliability of

trained inspectors. BMWED supports the FRA's balanced approach and is calling for public opposition to the AAR's waiver request. The union encourages citizens, lawmakers, and community leaders to submit comments before the June 9, 2025 deadline, urging the FRA to reject the proposal to cut back on visual inspections.
