### Invitation for Bids to Replace Roof System – Mercer County Public Library

**Bid opening will occur on Monday, June 30 at 11:00 am EDT in the Library Meeting Room.**

The Mercer County Public Library will accept sealed bids for the replacement of the library's roof at 109 W. Lexington St., Harrodsburg, KY until the date and time stated above. Bidders are welcome to call the library director at (859) 734-3680 x 101 to arrange a time for inspection.

Envelopes containing sealed bids must be clearly identified with the words "MCPL Roof Bid" in the lower left front corner. Interested parties must have at least 5 years of experience installing commercial roof systems on buildings over 10,000 square feet. Commercial roofing references are required.

- All bids must include the removal and disposal of the existing roof system down to the metal deck.
- Bids must include replacement of existing flat roof system with a system that drains standing water to existing roof drains.
- Bids must include planning to account for HVAC and any other mechanical units existing on the current roof.
- Bids must contain provisions for a 15 to 20 year warranty guaranteed by a third party and pursuant to an inspection of the completed roof by this party.
- Bids must document:
  - ◊ That insurance is carried by your company for damages and/or injuries that occur during work.
  - ◊ At least 3 references concerning installation experience of commercial roof systems.
  - ◊ Estimated time frame for installation.

The criteria for making the award shall be best value price for all responsive and acceptable offers. The Board of Trustees reserves the right to accept or reject any and all bids. Bids may be mailed to the library or dropped off at the circulation desk during regular business hours.

time of 11:02.76. A squad of Sanders, Krish Patel, Dunn and Alcorn competed in one of the most challenging events of the day, the 4x400 meter relay. Their time of 3:33.50 was enough to earn them a place on the podium, and two points for the boys.

The Titans struggled on the track for much of the meet, it wasn't until the final moments that they started to make a comeback in team scoring. In the lead up to the mile-relay Mercer was placed just outside of the top-10 teams, but after the two-point performance in the relay and the delayed entry of results from the shot put pit, Mercer boys skyrocketed in points, eventually finishing in fourth place overall, just .5 points behind rivals Boyle County. The Titans were able to make the comeback largely in part to dominant performances in the throwing pit from sophomore Noah Nichols and senior Gage Bennett. Shot put was put on hold to begin the meet, and officials were forced to flip the order of events, allowing girls to compete in discus first and shot put before the top boys competitors finally entered the pit. Nichols and Bennett began their day in the discus ring, where they finished fourth and tenth respectively with throws of 150'4" and 125'11." In quick succession, the duo made their way to shot put, where they would blow away the competition. The Titans eventually earned 18 points from

the event. Nichols mark of 52'7.25" placed first overall, and gave himself a cushion between him and second place finisher Bennett, who's mark of 50'2.75" earned eight points for his team. Most of the Titans successes at the state meet happened off of the track. The Lady titans first individual state champion of the day was named moments earlier, when Maddi Baker launched the discus an impressive 129'6," more than 10 feet further than the second placed competitor.

"I'm very proud of our throwers. They are very dedicated and put in a lot of extra work. Coach Mike Johnson has done a great job with the kids at practice, and then they also take private lessons from coach Josh Smith outside of our practice," said Mercer County Head Coach Lynn Flach, adding, "If you want to be a state champion it takes more than normal practice."

Dunn went on to claim third place in the long jump event. His leap of 20'1" earned an important six points for the Titans. Ralasia Piazza and Moore placed fifth and ninth respectively in the triple jump event with leaps of 33'3.25" and 31'9."

In the end, Mercer continued its tradition of winning at the state track and field meet, but they couldn't find enough points to seriously challenge for the title. Covington Catholic won the competition decisively, their 85 points was

33 more than second place finishers Bourbon County. Unfortunately, Boyle County finished with 48.5 team points, compared to the Titans 48. Paducah Tilghman rounded out the top-five team with 38 points. On the girls side, the Lady Titans placed 13th out of 35 teams. Lexington Catholic and Calloway County went stride-for-stride for much of the meet, but eventually Lexington Catholic pulled away with 88 team points.

The Titans have struggled staying healthy this spring and a few individuals even regressed in their events throughout the season. Whether injury or a less serious setback, the Titans had several athletes who were expected to be competitive at the state level, who didn't qualify, or didn't attempt to qualify for the state meet. It's a testament to the talent of the athletes that did earn the team points in Lexington that Mercer was able to finish in the top-5, but the underclassmen, several of which have already claimed individual regional or state championships, will need to step up and lead the program in the coming years if they are to return to their dominance at the state level and earn another state title, which would be their first since 2023.

"Every year we lose some good seniors and have to rebuild. It will be interesting to see who will step up and lead next year," said Flach.
