

# Lindsey Wilson College to become Lindsey Wilson University

Lindsey Wilson College will become Lindsey Wilson University on July 1.

That unanimous decision was made on Thursday afternoon by the Lindsey Wilson College Board of Trustees “to reflect the mission, character, and direction of this incredible school,” said Lindsey Wilson Board of Trustees Chair Denny Howell of Louisville, Kentucky.

“This is a historic day for Lindsey Wilson as it continues a remarkable journey that started more than 120 years ago,” said Howell.

Lindsey Wilson President William T. Luckey, Jr. said the change was necessary, because the school is “far more complex than it was even 10 years ago.”

Lindsey Wilson’s 2024 fall enrollment was a record 4,147 students, which included students from 49 countries and six continents. Lindsey Wilson operates campuses in six states, and about 60% of its students

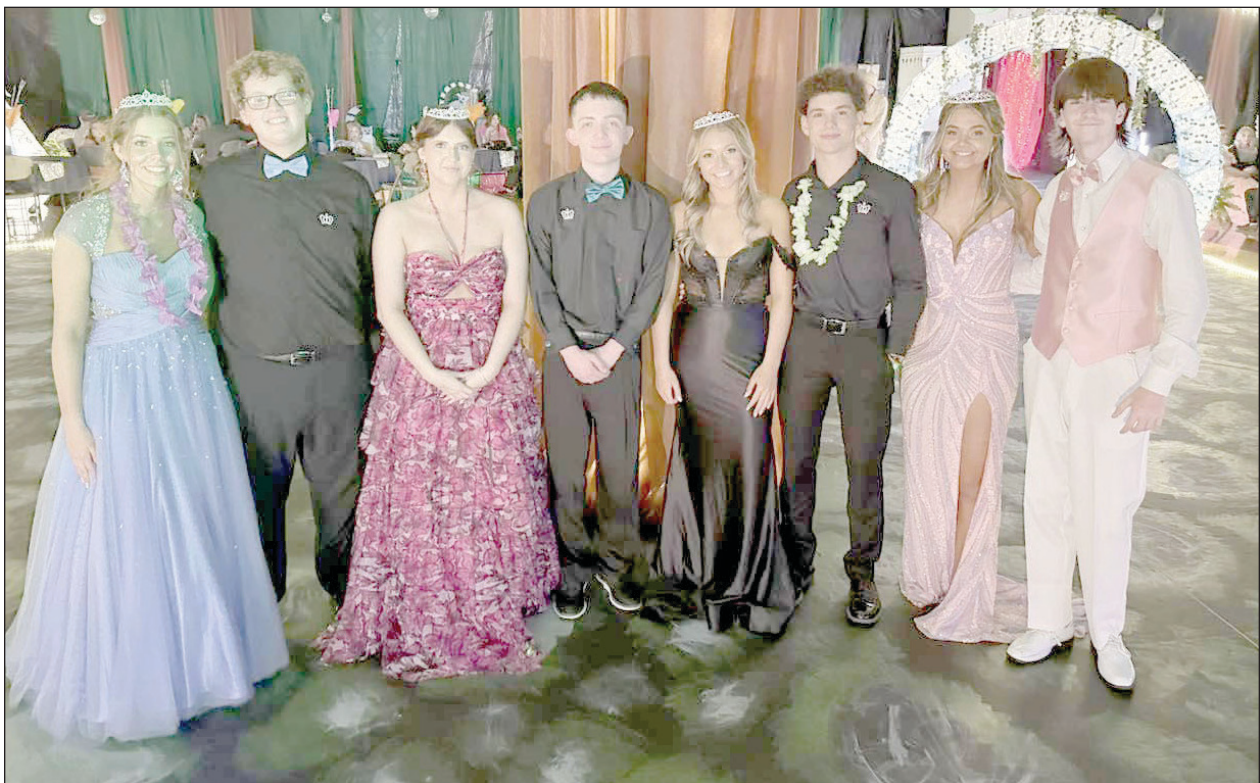
are enrolled in graduate or doctoral programs. The college is set to award 876 undergraduate and graduate diplomas at its May 2-3 spring commencement weekend. Combined with its winter class of 843 graduates, Lindsey Wilson will graduate a record 1,719 students this academic year.

Luckey, who has served the college for a total of 42 years, said the change is one he has been “wrestling with and even arguing against for at least 25 years.”

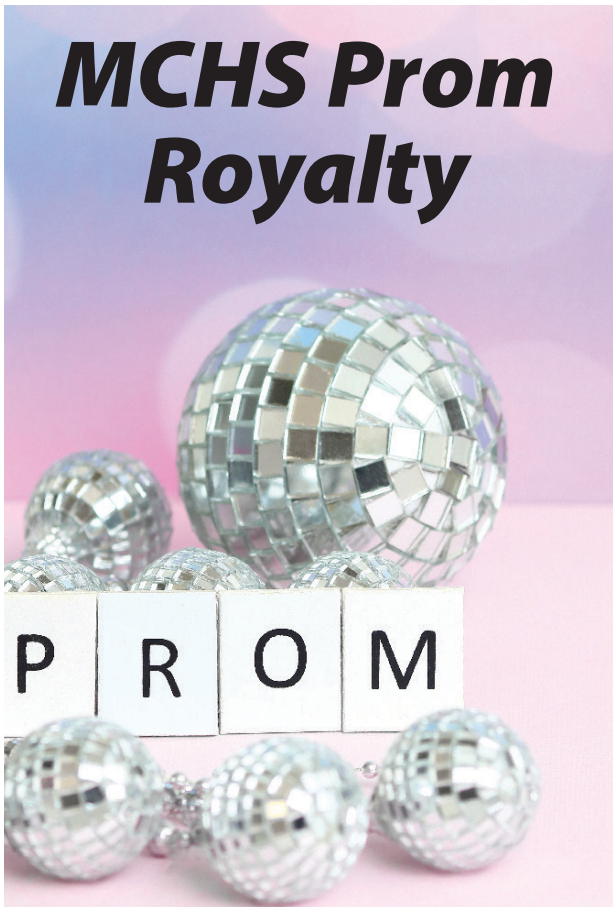
“I’ve always been convinced that the best teaching and learning in the world happens at small, private colleges across the United States,” said Luckey, who is the longest-serving college or university president in Kentucky higher education and has been Lindsey Wilson’s eighth president since 1998. “That is why this move does not change our mission, who we serve or what we do, but rather it reflects the dynamic nature of who we have become.”





**LEGAL NOTICE**

Notice is hereby given that Green Taylor Water District (“District”) plans to file with the Public Service Commission on or before May 1, 2025 to adjust certain non-recurring charges. The proposed effective date is June 2, 2025. The proposed changes are as follows:

- Currently, Green-Taylor Water District assesses a \$1.50 fee for credit/debit card transactions. Green-Taylor Water District is proposing to change its tariff to state the following: “When a customer makes a payment by credit card or debit card, the processor (not the District) will assess a convenience fee for providing this service. Prior to processing the transaction, the customer will be informed of the fee amount.” The amount of the convenience fee assessed by the processor will be actual cost.”
- Green-Taylor Water District’s customers mail in their meter readings monthly. Green-Taylor is requesting as part of its leak adjustment policy that to be eligible for a leak adjustment the customer must submit actual monthly meter readings to the District so that the customers adjustment is based on actual usage and not estimated readings.
- Green-Taylor Water District is proposing to change delinquent penalty from the 20th day of the month following the month of water usage to the 15th day of the month following the month of water usage.
- Green-Taylor Water District is proposing to change the disconnect date for nonpayment from the 15th day of the month following the month the bill is received to payment must be received by end of business day on the 20th day of the month following the month of water usage or customer will be subject to disconnect on the 21st.
- Green-Taylor Water District proposes to add ACH-Bank Draft/Automatic policy to its tariff. Where the customer can elect to have their bill paid by bank draft to the District at no charge to the customer. The ACH-Bank Draft will be withdrawn on the 10 of each month.

Any person may submit comments regarding this tariff filing by mail to the Public Service Commission, Post Office Box 615, Frankfort, KY 40602; or through its website at <http://psc.ky.gov>.

The rates contained in this notice are the rates proposed by the District, but the PSC may order rates to be charged that differ from the proposed rates contained in this notice.

Any person may submit a timely written request for intervention by mail to the Public Service Commission, Post Office Box 615, Frankfort, KY 40602. The request for intervention must establish the grounds for the request including the status and interest of the party.

If the PSC does not receive a written request for intervention within thirty (30) days of the initial publication or mailing of notice, the PSC may take final action on the tariff filing.
