Parents of ANY Metcalfe County child (ages 2-18) can pick up a 5-day BULK MEAL pack for breakfast and lunch. Children do not have to be enrolled in Metcalfe County Schools. All food items are on a first-come, first-serve basis unless you are registered to get meals through this form.

All meal packs are either pre-packaged or require minimal cooking and will consist of the following meal components:

- ✓ Breakfast - Entrée (grain-based), fruit or juice serving with milk
- ✓ Lunch - Entrée (grain and meat), fruit, vegetable, and milk servings

Please complete the following questions to request FREE bulk meal pick up. ALL children must be listed to get one meal kit per child.

If you choose to participate in this program, you should not get meals from another open site that serves hot or bulk meals. Metcalfe Elementary School will be open for breakfast (7am-8am) and lunch (11:00-12:00) Monday-Friday from June 2 - June 27.

The City of Edmonton will receive sealed bids for two projects at the City Hall, located 207 East St, Edmonton, KY 42129. Project scope (demolition and new construction) will be divided into two separate contracts, seeking work for:

General Contractor to construct new vestibule walls and refinish areas with new flooring, ceilings, paint and other building components described in the construction documents.

Hardware Contractor to install new access control door hardware devices, door panels, and frames as described in the construction documents.

Bids will be received at the **Edmonton City Hall, 207 East St, Edmonton, KY 42129**, where bids will be publicly opened and read aloud.

All bids must be received on or before 1:00 PM (central time) on Wednesday, May 28, 2025.

The Form of Proposal is a part of the front-end specifications. All bids shall be submitted only on the Form of Proposal and in a sealed envelope. The sealed envelope shall have the Project Name clearly marked, along with the respected bidder's information.

Deco Architects, Inc. is the Architect of Record for this project, acting as agent for the Owner and acting

on the Owner's behalf in soliciting your proposal. Successful Bidder will have a Contract directly with the Owner.

Bid Proposal Forms must be properly filled out and submitted in duplicate. No qualifying letters or statements will be considered. No bidder may withdraw a bid submitted for a period of sixty (60) days after the date for the opening of the Bid.

In the event the Bidder to whom the Contract is awarded fails to execute a satisfactory Contract, they shall be eliminated and shall be liable for the loss incurred by the Owner by such failure.
