Kentucky has been at the forefront of the opioid crisis since the early 2000s. According to the National Institutes of Health (NIH.gov), the Commonwealth has consistently ranked among the highest

Speaker Matt Hunt was welcomed. Hunt is the Director of the Barren River **District Health Department** of which Metcalfe, Barren, Hart, Simpson, Butler, Logan, Warren, and Edmonson County health departments are members. He referred to the many programs that are required by state statute for the county health department to perform.

Hunt began, "You know, by statute, all counties, 120 counties in the state are

required to have a local health department. And so, things like, think about Communicable Disease Control. Think about, vaccines, and tuberculosis control. I know we've had TB, we've talked about that across the district...Think about adult and childhood vaccinations. That's a requirement by statute...Other things you

think about chronic disease management. "

He continued, "You think about restaurant inspections, on-site septic if you build a house in the country, things like that, or, again, things that you must do as a health department.
