

Lexington councilwoman Denise Gray won’t seek reelection, cites harassment

Lexington councilwoman Denise Gray will not seek reelection, she announced Sunday afternoon.

Gray said after much prayer and reflection, she decided to not seek a second term as the sixth-district councilperson for the Lexington Fayette County Urban Government.

“Serving you, my neighbors, my hometown community, and the district where I was raised has been an honor that words can hardly capture,” Gray stated in a press release. “Together we’ve asked hard questions, challenged the status quo, and worked toward a more just and equitable Lexington. I am proud of what we’ve built.”

Gray said her decision to not run again for a Lexington council seat was a result of treatment by media following her sexual assault allegations against former council member Brenda Monarrez.

Monarrez was accused of sexual assault against Gray in August 2024. On Aug. 8, 2024, Gray applied for a restraining order, called an interpersonal protection order, alleging Monarrez was sexually aggressive toward her on two occasions over the prior three years.

In October, District Judge Traci Brislin granted a three-year restraining order between the two women and found sexual assault did occur.

“I believe an actual sexual assault occurred, and it may occur again,”

“The court believes that this has happened on not one, but two separate occasions.”

Sexual assault under state statute also includes sexual abuse. No criminal charges have been filed against Monarrez.

Gray said her decision to not seek reelection wasn’t easy.

“The lack of empathy and disregard for my humanity during that time was not only hurtful, but it was also a painful reminder of the barriers Black women too often face when we speak truth and stand in our power,” Gray said. “Despite that treatment, I continued to show up and serve with courage, compassion, and commitment. But I will not pretend it did not affect me, it did.”

Gray was elected in November 2022 to represent Lexington’s sixth district, which stretches along Lexington’s north and east sides with Paris Pike, Winchester, Liberty, Man O’War and Bryan Station roads as major corridors.

As a result of the sexual assault claims, Monarrez was banned from entering city hall and Democratic party events. Monarrez, who represented district four, lost her seat to Emma Curtis in November 2024.

Two infants have died of whooping cough in Kentucky

Two infants in Kentucky have died of whooping cough in the last six months, the Kentucky Department for Public Health confirmed Friday.

The deaths from pertussis are the first in the state since 2018.

Pertussis is a highly contagious bacterial infection that settles in the respiratory system. A deep and persistent cough that resembles a “whooping” sound is often a signature symptom, earning the illness the name whooping cough.

Neither of the babies or their mothers were vaccinated against whooping cough, state officials said. Pertussis immunizations are recommended during pregnancy or infancy, starting at two months old.

The health department did not immediately provide details on exactly how old the infants were, or where in Kentucky the deaths occurred.

“Anyone can get whooping cough, but infants are at greatest risk for life-threatening illness,” said Public Health Commissioner Dr. Steven Stack said in a statement. “Fortunately, when vaccinations are administered to pregnant women, it provides protection to both the mother and the

baby.”

State health officials in July 2024 warned that whooping cough cases were spiking statewide to levels not seen in at least a decade. Last year, 543 cases were reported — the most since 2012. At least 247 cases of whooping cough have been reported so far this year. Health officials expect the prevalence of cases to continue through the summer and fall.

Since it’s an airborne illness, whooping cough is especially contagious. Though they typically vary depending on one’s age and vaccination status, symptoms usually begin with congestion, runny nose and mild coughing.

After a few weeks, symptoms can progress to labored breathing and a more severe “whooping” cough, fever and sometimes vomiting.

The illness is combined with the tetanus and diphtheria vaccines and is required for school-aged kids in Kentucky.

Only 86% of Kindergartners and 85% of seventh graders are up to date on their required pertussis vaccines, according to a state immunization survey from the 2024-2025 school year.
