Butler County had not won a conference game all season but made an improbable run to the title game. Butler County cut the deficit to four just before halftime, but McLean responded by extending the lead back to double digits in the third quarter. From there, they traded baskets with the Bears before securing a 39-29 victory and their second consecutive GRVC title.

While the Cougars have solidified their place in school history, Caine remains uncertain about his long-term coaching future. However, Grayson County hit two clutch free throws with 0.2 seconds left to force overtime before sealing the win in double OT.

With the district tournament approaching, McLean County looks to continue building momentum and improving late-game execution in hopes of making a postseason run.




