AN ORDINANCE OF THE CITY OF LIVERMORE, KENTUCKY, AMENDING THE RATES AND CHARGES FOR THE USE OF AND THE SERVICES RENDERED BY THE CITY'S WATERWORKS SYSTEM.

ORDINANCE NO 1-91-A10

WHEREAS, in and by provision of Kentucky Revised Statutes in is required that rates for water service (the "Service") provided by the City's waterworks system be prescribed and maintained so as to provide for the payment of interest upon and principal of outstanding Bonds as the same become due, to pay operating and maintenance costs and to provide for depreciation of the
