AN ORDINANCE OF THE CITY OF LIVERMORE, KENTUCKY, AMENDING THE RATES AND CHARGES FOR THE USE OF AND THE SERVICES RENDERED BY THE CITY'S WATERWORKS SYSTEM.

ORDINANCE NO. 1-91-A10

WHEREAS, in and by provision of Kentucky Revised Statutes it is required that rates for water service (the "Service") provided by the City's waterworks system be prescribed and maintained so as to provide for the payment of interest upon and principal of outstanding Bonds as the same become due, to pay operating and maintenance costs and to provide for depreciation of the system, and

WHEREAS, the City's present rate schedule set forth in a Rate Ordinance enacted by the City of April 17, 1984, as amended, is deemed inadequate and it is necessary, desirable and appropriate at this time that a schedule of amended rates for Service be prescribed and that provision be made for the collection thereof; NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF LIVERMORE, KENTUCKY, AS FOLLOWS:

B. Meter Rates for Water Usage in Addition to Minimum Charge. Subject to the minimum monthly rate specified above, the following metered charges shall be made for each 1,000 gallons of water consumption per month to customers of all size connections:

Number of Gallons of Water per Month	Monthly Charge Per 1,000 Gallons (Inside City Limits) <i>Effective March 1, 2025</i>
First 1,000 gallons or less	\$15.82 \$16.02
All over 1,000 gallons	\$8.83 \$9.03

Number of Gallons of Water per Month	Monthly Charge Per 1,000 Gallons (Outside City Limits) <i>Effective March 1, 2025</i>
First 1,000 gallons or less	\$18.08 \$18.28
All over 1,000 gallons	\$9.83 \$10.03

Number of Gallons of Water per Month	Monthly Charge Per 1,000 Gallons (Inside City Limits) <i>Effective January 1, 2026</i>
First 1,000 gallons or less	\$15.97 \$16.17
All over 1,000 gallons	\$8.98 \$9.18

Number of Gallons of Water per Month	Monthly Charge Per 1,000 Gallons (Outside City Limits) <i>Effective January 1, 2026</i>
First 1,000 gallons or less	\$18.23 \$18.43
All over 1,000 gallons	\$9.98 \$10.18


The minimum charges set forth above each include a charge of \$1.00 per month charged for this water maintenance reserve account. Said reserve account may only be used for repairs to the City's water distribution system, including, but not limited to, water storage facilities, distribution and transmission lines and pumping stations. This ordinance becomes effective immediately upon its adoption, approval, and publication as provided by law, and the rates set forth herein become effective as stated therein. First reading to record was at a regular meeting on the 13th day of February, 2025.
