and how they can be poison to ourselves and others. I was so convicted."

Paul offers this example of a sweet-smelling sacrifice. In Philippians 4:18 we read, "Indeed I have all and abound. I am full, having received from Epaphroditus the things sent from you, a sweet-smelling aroma, an acceptable sacrifice, well pleasing to God."

While that sin problem persists, we have a permanent solution in Jesus Christ, our Lord. He was the blood sacrifice that takes away all sin, forever. And even though we do not need to work our way to our Heavenly home, people should be able to tell that we know the way there by our actions and the fruit we produce. This means laying down our lives and taking up the cross of Iesus!

Conviction produces action, otherwise, it is simply guilt, and we

know born-again believers are free from the past. If you are seeking a closer walk with God, step into the Word and walk closer to Him.
