dwelling needs evaluator with AACS' weatherization program, was in the middle of conducting a duct blaster test. "What we're going to be doing with this (test) is making sure that the new install of (the home's) HVAC unit, all the air that's popping through the system, stays in there," Bean said Tuesday. "Otherwise, your dollars are just going right to the outside. We want to keep every energy dollar inside the house that we can."

For Bean, the work itself is more than having employment.

"It brings purpose to the job," he said. "It's not about a profit here; it's about helping the community around us. And at the end of the day when these jobs are finished, it really does feel nice."

"We get letters from people saying how grateful they are .... It's great to see," Bean said. "I actually got this job because my mother signed up through the program and they did work on her house ....

"Now I'm here, paying it forward," Bean said. Green said Tuesday was the start of the weatherization collaboration with AACS regarding the subdivision — which will consist of 10 total houses upon completion. For Harley, he finds fur-
