He was a dedicated crew member for his sons' late model stock cars, helping them compete at venues like Kentucky Motor Speedway and the Nashville Fairgrounds, as well as traveling in the NASCAR Elite **Division Southeast** Series in the 90s and 2000s. He also lent his expertise to local drivers like Michael Canary and his son, Luke, working on their dirt track cars.

In addition to his love of the outdoors and racing, Gale was a skilled and respected concrete finisher and contractor. He worked in the concrete industry for 65 years, operating his own business from 1984 until his retirement in 2022. He was especially proud of building his home with his own hands alongside his son, Randy, in 1984, and, in the last decade of his life, building a cabin on his farm where he spent time hunting, fishing and making memories with loved ones.



Gale's life was one of devotion to his family, his community and his passions. His contributions will never be forgotten, and he will always be remembered as a man of integrity and generosity with a steadfast love for those around him.

Ex-Kentucky clerk Davis again asks Supreme Court to hear her case

She hopes to overturn gay marriage

LEXINGTON — The former Rowan County clerk who was briefly jailed for denving marriage licenses to gay couples a decade ago has again asked the Supreme Court to hear her appeal in hopes of overturning the nationwide right to same-sex marriage.

Kim Davis has persistently fought back against lawsuits filed against her by the couples she denied licenses to. Now, her attorneys with Liberty Counsel are asking the high court to weigh in on three points:

- Whether Davis' First Counsel attorneys wrote in one of the couples to Amendment religious liberty rights were infringed upon when she was asked to certify marriage certificates for gay couples, since it violated Davis' evangelical Christian beliefs.

Whether she has qualified immunity that should shield her from having to pay, now as a private citizen, hundreds of thousands of dollars in damages to the gay couple who has since suea ner.

- And whether the very case that legalized gay marriage in 2015, Obergefell v. Hodges, should be overturned.

This court should revisit and reverse Obergefell for the same reasons articulated in Dobbs v. Jackson Women's Health Center," Mat Staver and other Liberty

their 90-page request filed Thursday, referencing the case that led to the overturning of Roe v. Wade, which had otherwise preserved the right to an abortion. 'Obergefell was wrong

when it was decided and it is wrong today because it was grounded entirely on the legal fiction of substantive due process," they added.

Substantive due process in this context refers to Davis' claim that because the legalization of samesex marriage fundamentally infringes on and deprives her of the freedom to assert her religious liberty, the passage of Obergefell was inherently flawed.

A lawyer for David Ermold and David Moore,

whom Davis denied a marriage license and who subsequently sued her — the case Davis is asking the Supreme Court to provide an opinion on — did not immediately respond to a Herald-Leader request for comment Thursday.

Liberty Counsel, an Orlando, Florida-based 'litigation, education and public policy ministry," argues that Davis was the "first victim" of Obergefell, because she was jailed and sued for standing strong in her "sincerely held religious beliefs on marriage.'
