tourism initiatives. Brown highlighted the organization's 25th anniversary and explained that Logan County Tourism is a special government entity, reporting to the Department of Local Government, the Fiscal Court, and the Kentucky Department of Tourism. Its annual budget, approximately \$50,000 to \$60,000, is primarily funded by a 3% transient tax on overnight lodging, collected by the county and then transferred to the tourism organization. "We at Logan County Tourist & Convention Commission are happy to be celebrating our 25th-year anniversary this year," Brown said.

"As we begin this new chapter, we look forward to good things ahead in the future. We plan to embrace this opportunity for change as we continue to advertise and promote Logan County with the same level of enthusiasm and dedication we always have." Tourism uses its budget to create county brochures, maps, and visitor guides. A recent grant helped fund new wayfinding signs throughout the county. Brown also detailed her role in organizing and promoting local events, including the Haybale Trail and Leadership Logan's Tourism Day, and her involvement on the County Fair board. She promotes local activities through

an email newsletter, social media, and a website. The tourism office collaborates with local, regional, and state tourism associations to increase awareness of Logan County and advocate for tourism-related legislation. The office's current hours of operation are 8 a.m. to 1 p.m. Upon relocation, the hours will change to 10 a.m. to 3 p.m. Logan County Tourism has the current office space in the courthouse rent-free through July 4. It has
