As friends, family, and coaches came to celebrate their achievement, the five athletes will look to create a legacy after their playing career is done at the high school level.

Starting with Sears, she signed her letter of intent to play volleyball at the University of Houston. She leaves Logan County holding multiple records, with the single-game kill record of 31 in a single match and the season and career kill records, finishing with 2089 career kills. Also holding the season and career records in blocks, finishing her high school career with 140. Sears was an important piece of the 4th Regional title team last year and their state tournament run.

For Taylor, she signed her letter of intent to cheer at Western Kentucky University. A dedicated cheerleader for many years, she has been a vital piece in the Logan County Cheer teams that competed and finished top-10 in the past two years at Nationals, in addition to cheering on the sidelines and courtside for the Cougars.
