AN ORDINANCE AMENDING THE CITY OF AUBURN, KENTUCKY, ANNUAL BUDGET FOR THE FISCAL YEAR JULY 1, 2024, THROUGH JUNE 30, 2025, BY ESTIMATING REVENUES AND RESOURCES AND APPROPRIATING FUNDS FOR THE OPERATION OF CITY GOVERNMENT

In accordance with KRS 83A.060(9), the undersigned, a licensed, practicing attorney in the Commonwealth of Kentucky, summarizes this Ordinance as follows:

1) This Ordinance amends the City's annual budget by amending amounts reflecting Revenue and Appropriations of the City of Auburn for fiscal year July 1, 2024 through June 30, 2025 to reflect the year's actual revenue and appropriations.

2) The full text of this Ordinance and its attachments is available for copying and inspection at the office of Maggie Hines, Auburn City Clerk, 103 East Main Street, Auburn, Kentucky during normal business hours.

3) The City Council of Auburn, Kentucky enacted this Ordinance after a first reading conducted on May 12, 2025, and a second reading and passage on June 9, 2025.
