Reed mentioned as possible candidate for US House

Republican state Sen. Aaron Reed of Shelbyville is being mum about a news report that he is being considered to be a candidate next vear for the U.S. House seat now held by Republican Thomas Massie.

Reed, who was elected to the Kentucky Senate last year, did not return phone calls from Paxton Media

seeking comment about a continue my service both June 29 article in Politico, as a fifth generation a political journalism Kentucky farmer and a organization based in Arlington County, Virginia, that said White House officials will host Reed in the coming weeks for a discussion about challenging Massie in the 2026 Republican primary election.

Reed, a former Navy SEAL who often wears a large cowboy hat, could run for Congress next year and keep his state legislative seat. If he won the congressional seat, he would have to leave the state post. A special election then would be held to fill the remainder of his legislative term, which runs through 2029.

The Courier Journal in a brief interview with Reed said he has no plans yet on whether to run against Massie. He said he has an ideological difference with Massie on Israel and, asked when he expects to make a decision about whether to run, said, "When God tells me."

If Reed, a gun store owner, leaves his state Senate post before his term ends, a special election would be held to fill the remainder of the term.

Massie has stockpiled more than \$1.7 million for his re-election bid as the Kentucky Republican gears up to face Trump's vaunted political operation, the Associated Press reported Tuesday.

Massie was one of two House Republicans to vote Republicans to vote against against Trump's massive Trump's "big, beautiful" tax bill. He also said Trump budget bill and Massie lacked authority to bomb nuclear sites in Iran without congressional approval. Trump aides launched a super PAC devoted to defeating Massie in his 2026 primary, the first concerted Trump political advisers effort by Trump's team to unseat a sitting member of Congress. Massie's campaign said Monday he raised just over \$584,000 between April and June and has raised more than \$1

million since the last election.

Shelby County farmer and former Navy SEAL Ed Gallrein lost to Reed in last year's Republican election by 118 votes.

Asked this week if he would be interested in seeking the state Senate seat again if it reopens, Gallrein said, "It would be an honor and privilege to serve the people of this Senate district in Frankfort to

career active duty senior Navy SEAL officer and now a senior advisor for Special Operations."

Democrat Rhonda Davis, whom Reed handily defeated - 40,538 to 19,112 in last November's general election, did not return a phone call seeking comment.

Shelby County farmer Paul Hornback, Republican who served in the state Senate for 12 years for Shelby County, said this week he has "no interest" in trying to return to the state legislature.

"I've always been for term limits and I think 12 years were enough," said Hornback, who noted that he has never been a supporter of Reed.

Reed represents the Senate's 7th District, made up of Shelby, Henry, Anderson and part of Jefferson County. It is about 50.4 percent Republican in voter registration.

Reed and Massie have had an interesting political relationship. Massie previously had endorsed Massie for state Senate and Reed once called Massie "one of American's greatest Congressmen."

But President Trump and his political operation have threatened to field a candidate against Massie and campaign "really hard" against him because Massie was one of the few opposed the president's Iran-Israel stance. Massie said Trump's threats led to his campaign taking in \$120,000 in a single day. Politico reported that Chris LaCivita and pollster Tony Fabrizio have launched a super PAC directed at defeating Massie that's already running a TV ad attacking the seven-term incumbent.
