Grants available for high school FFA, 4-H and HOSA chapters

FRANKFORT — Raising Hope, a Kentucky Department of Agriculture (KDA) program focused on farm safety, farm rescue and farmers' health, is providing grant opportunities for high school FFA, 4-H and HOSA - Future Health Professionals chapters to focus on those vital components, as well. Agriculture Commissioner Jonathan Shell announced KDA's Raising Hope program is investing \$200,000 for the grants, an increase of \$75,000 over last year's funding.

"As Kentucky's Agriculture Commissioner, I am proud to support this initiative that empowers our high school student chapters to address vital issues in agriculture," Commissioner Shell said. "By focusing on farm safety, farmers' health and farm rescue, we are investing in the well-being of our farming communities and ensuring that our next generation of leaders is wellequipped to face these challenges. KDA's Raising Hope program raises awareness about farm safety, health risks and farm rescue, stressing the importance of training for farmspecific rescues to enhance safety for farmers, workers, and families. With the commitment of \$200,000 from Raising Hope, high school chapters for FFA, 4-H and HOSA can apply for grants to host events dedicated to farm safety, farm rescue and farmers' health, both mental and physical. The money will be in allotments up to \$5,000 to winning chapters.

"Kentucky FFA is excited about the opportunities made possible through the Raising Hope Grant," said Kristan Wright, Agricultural Education Consultant/State FFA Advisor. "We have witnessed the tremendous impact these grants have made across the state, whether through the Challenge Coin Program, farm safety days, or farm safety kits. This year, chapters will have the opportunity to continue saving lives. These efforts teach our members the importance of giving back to their local value of our farmers and agricultural professionals. The impact of this grant will be felt throughout the broader agricultural industry and the communities we serve."

"By participating in the Raising Hope program, HOSA chapters across Kentucky are planting the seeds of innovation where agriculture and healthcare intersect," said Susan Readnower, HOSA State Advisor. "HOSA — Future Health Professionals is more than a student organization; it's a pipeline preparing the next generation of leaders in medicine, public health and allied health careers. With this opportunity, we are empowering students to explore how rural health and sustainable agriculture directly impact community wellness — raising hope for a healthier tomorrow. AN ORDINANCE AMENDING MUNICIPAL CODE CHAPTER 9.08 SECTIONS 9.08.010, 9.08.030, 9.08.050, AND 9.08.060 WHICH REGULATE RATES, CHARGES AND USAGE OF THE MUNICIPAL WATER AND SEWER SYSTEMS AND ENACTING A NEW SECTION OF SAID CHAPTER PERTAINING TO RATE AND CHARGE INCREASES

WHEREAS, the City of Milton finds it necessary from time to time to amend the rates and other charges for water and sewer se

vices furnished by the city; and WHEREAS, the City of Milton finds it necessary to recalculate current rates to maintain a balance with the costs of providing se

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF

MILTON, KENTUCKY AS FOLLOWS: SECTION I. AMENDMENT OF MUNICIPAL CODE SECTIONS PERTAINING TO WATER AND SEWER SERVICE RATES he following sections of the City of Milton Municipal Code are

nereby amended as follows SECTION 9.08.010 - Monthly Water Rate

he rates and charges for water services furnished by the City are fixed and established on a monthly basis as follows: A. Minimum Monthly Bill. The minimum water bill shall be twentyve dollars (\$25.00) per month, and each water customer shall be entitled to one thousand (1,000) gallons (or less) of water each month for such minimum charge.

Meter Rates for Water Usage in Addition to Minimum Charge. Subject to the minimum monthly water specified above, after one thousand (1,000) gallons of consumption per month, customers shall pay [five dollars (\$5.00)] ten dollars (\$10) per one thousand (1,000) gallons used. The foregoing month water rates shall be applied in increments of one hundred (100) gallons or less. [On luly 1, 2022 and on July 1 of each succeeding year, there may be an additional increase in the rates if determined necessary by the Commission.]

SECTION 9.08.030- Sewer user charge system. Rates or charges for sewer service shall be based insofar as possible upon respective building or premises.

The rates and charges for sewer services furnished by the City are fixed and established on a monthly basis as follows: A. Minimum Monthly Sewer Rate. The minimum monthly bill for ewer service shall be [sixteen dollars and twenty five cents (\$16.25)] **twenty-five dollars (\$25)**, and each sewer customer shall be entitled each month to discharge water into the municip al sewer system based upon water usage of one thousand (1,000) gallons or less for such minimum sewer charge of [six-teen dollars and twenty five cents (\$16.25)] twenty-five dollars

B. Sewer User Rates (Based on Metered Water Usage, in Addition to Minimum Charge). Subject to the minimum monthly rate specified in subsection A of this section, a charge of [four dollar and fifty cents (\$4.50) nine dollars and fifty cents (\$9.50) monthly sewer user charges shall be made for each one thousand (1,000) gallons of water discharged into the municipal sew er system, based on metered water usage. <u>SECTION 9.08.050</u> - Waterworks connection charge. The water-

works connection charge shall be [nine hundred dollars (\$900)] one thousand five?hundred dollarsj\$1500) for all size meters plus a materials cost difference between a three-guarter (3/4) inc meter and a larger meter. [In all other respects the existing ances establishing rates and charges remain as enacted.] <u>SEC-TION 9.08.060</u> - Sewer connection charge. The sewer connecfive hundred dollars (\$1500) for a residential five-eighth (5/8) inch by three-quarter (3/4) inch meter size, [seven hundred fifty dollars (\$750)] one thousand seven hundred fifty dollars (\$1750) for a commercial five-eighth (5/8) by three-quarter (3/4) inch meter size, and plus the material cost difference between a five-eighth (5/8) inch by three-quarter (3/4) inch meter size on any

larger meter requested. SECTION II. ENACTMENT OF NEW MUNICIPAL CODE SEC-TION PERTAINING TO WATER AND SEWER SERVICE RATES new Section of Chapter 9.08 of the City of Milton Municipal Code is hereby enacted as follows: SECTION 9.08.100 - In-

creases in water and sewer rates. The rates and charges for water and sewer services, including connection charges, set forth in this Chapter shall be subject to adjustment at any time as deemed necessary by the Commissior However, any increases in said rates or charges shall not take ef fect until at least ninety (90) days following the enactment of the

SECTION III. SEVERABILITY All sections of the previously enacted ordinances pertaining to rates, charges and usage of the municipal water and sewage sy ems not affected by this Ordinance remain in full force and effect f any clause, provision, paragraph, or section of this Ordinance be ruled void or unenforceable by any court of competent urisdiction, the remainder thereof is intended to be enacted and shall be in full force and

season with a record of 5-1 after defeating the Gallatin County Wildcats 26-0 last


